

**RESOLUTION NO 1031-2020**

**A RESOLUTION CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE SPECIAL AND GENERAL ELECTIONS HELD ON NOVEMBER 3, 2020 FOR THE PURPOSE OF ELECTING A MAYOR AND CITY COUNCIL MEMBERS (PLACES 4 & 5) IN THE CITY OF RIVER OAKS, TEXAS; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, a special election was called for on July 28, 2020 with the adoption of Ordinance 1003-2020 and held on November 3, 2020 in order to elect **City Council Member, Place 4** to fill the unexpired term until May of 2021 or until their successor is duly elected and qualified; and

**WHEREAS**, a general election was held on November 3, 2020, for the purpose of electing the Mayor and Place 5 member to the City Council; and

**WHEREAS**, the special and general elections was duly and legally held in conformity with the election laws of the State of Texas, and the results of said election have been verified and returned by the proper judges and clerks; and

**WHEREAS**, it appears that a total of **2,521** ballots were cast in the Elections including absentee, early and general election votes; now, therefore,

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVER OAKS, STATE OF TEXAS:**

**Section 1.**


