1. CALL TO ORDER

With a quorum present, Mayor Houk called the Regular Meeting of the River Oaks City Council to order at 6:01 p.m. on Tuesday, June 3, 2025 at River Oaks City Hall, 4900 River Oaks Blvd., River Oaks, Texas 76114.

2. INVOCATION

CM Rodriguez delivered the Invocation.

3. PLEDGE OF ALLEGIANCE TO UNITED STATES FLAG AND THE TEXAS FLAG

CM Rodriguez led the Pledges of Allegiance to the United States and the Texas Flags.

4. READING OF PROCLAMATION(S) AND SPECIAL PRESENTATIONS BY MAYOR.

-GIVEAWAY TO GRAND PRIZE AND CONSULTATION PRIZE WINNERS FOR THE MAY 2025 TASTE OF RIVER OAKS EVENT

We had eight blackouts and over 70 bingos. During this, restaurants did mention that business has increased. Mayor Pro Tem Turner drew names: Grand Prize is a cooler with over \$200 in gift cards-Linda Claridge Sr; Second Prize which is a gift bag and a gift card from Grumps-Toni Cryer; Third Prize which is a basket of items from Boulevard Brew and JJolly's-Sonia Vasquez. This event was paid for by EDC. EDC members in attendance were President Darren Houk, Members Dan Chisholm, and Member Charles Richardson which were presented T-shirts. Richard Jones was present online. It was said that the current website is not user friendly, things were not easy to locate, and it is not a very modern site. City of Lake Worth and City of North Richland Hills are client examples. The new website will be ADA compliant, and you can access it on any device. There is a help center online. Support is the same as for small cities as it is for large cities. Richard showed the City of North Richland Hills, City of Forest Hill, City of Lake Worth, and City of Kennedale's websites. Also shown is a map of other surrounding cities that are using Civic Plus. Also shown the nationwide locations that use Civic Plus. Will send out tonight the design costs.

9. CONSIDER APPROVAL OF REQUEST FROM SANDRA LONGORIA DAMIAN REQUESTING PERMISSION TO PERMIT A TEMPORARY PICKUP AND DROPOFF LOCATION FOR U HAUL RENTALS AT 1711 ROBERTS CUT OFF ROAD.

Sandra Longoria Damian and Rebecca Castro were present. This property was purchased recently and has a proposal for a River Oaks Community Hub. This hub will have co-working space, internet, real estate, some printing services, conference room, podcast room, and an open room that is library style that will have some books. Will be working with Castleberry ISD. Wants to

help revive the Chamber of Commerce. To help bring in some money during remodeling, would like to open a web-based U-Haul drop-off and pick up at this location. It will consist of only two small trucks. The zoning ordinance doesn't permit it nor allow it. No one will be allowed inside. The plan is to concrete the back area for the U-Haul trucks. This is only a temporary occupancy for three months until the permanent occupancy gets approved in the fall. This is to help get some income in while doing the remodeling.

CM Forester moved, seconded by CM Rodriguez to allow the web-based U-Haul drop off and pick up, and limit this to two vehicles that are 14-foot trucks through September 2, 2025. All voted "Aye".

Jason Gleva was present. All permits have been pulled, and a timeline has been presented. Got a partner now to help financially. It should take 12 weeks (90 days) to complete.

CM Forester moved, seconded by CM Claridge to extend an additional 90 days from May 17, 2025. All voted "Aye".

CM Claridge moved, seconded by CM Rodriguez to deny Ordinance #1450-2025. All voted "Aye".

CONSIDER APPROVAL OF ORDINANCE #1451-2025 AMENDING CHAPTER 13 "UTILITIES" OF THE RIVER OAKS CODE OF ORDINANCES (2020) REVISING DIVISION 2 "WATER SERVICE POLICY" SPECIFICALLY UNDER SECTION 13.02.033 "PAYMENT ARRANGEMENTS" SUBSECTION (a) AND SECTION 13.02.037 "DISCONNECTION OF UTILITY SERVICE" SUBSECTION (a) REGARDING UTILITY SERVICE DISCONNECTION OF A DELINQUENT WATER ACCOUNT.

The policy should read: In order to avoid utility service disconnection for a delinquent account, the account holder must contact the utility office prior to 5:30 p.m. the day before the disconnection date and make arrangements to pay the utility charges; and All water accounts that are considered delinquent will be disconnected at of 7:30 a.m. on the disconnection date unless the disconnection date falls on a holiday or weekend, then the disconnection will be delayed to the next business day at 7:30 a.m.

CM Holland moved, seconded by CM Claridge to approve Ordinance #1451-2025. All voted "Aye".

OTHER ITEMS FOR DISCUSSION AND/OR ACTION:

14. DISCUSSION AND/OR ACTION ON REQUESTED AMENDMENT TO ETHICS POLICY BY CITIZEN.

CM Holland, who received a letter from Matthew Tatarko, asked for this to be put on the agenda. Dr. Tartarko is proposing an amendment to restrict council members from protesting their personal property taxes. Tarrant Appraisal District's job is to access values. They look at city permits, sales of homes, etc. The city is not involved in this process. Everyone can make their case and try and get their values lowered. The property tax calendar is: January-April TAD determines market value; April 15th, TAD releases values; April 15th-May 15th, values can be negotiated with TAD; May 15th, protests must be filed with TAD; May 15th-July, TAD ARB hearings are held; July & August, TAD sends certified roles to taxing entities; September, taxing entities determine tax rates and access taxes; October, Tarrant County mails out tax statements. Homeowners with homestead exemptions, the values can only increase by 10%. Other properties that are not homesteaded, the values can increase a lot more. The city is getting more money from investment properties than homeowners. CM Holland pays about \$32,000.00 in property taxes a year. This is not an ethical issue.

Dr. Matthew Tatarko, 4858 Hope-believes this is an ethical issue. This takes money away from the schools and cities. Dr. Tatarko has protested his value once due to an error but doesn't protest each year. CM Holland is the only one on the council that protests taxes. CA Anderlee told Dr. Tatarko that he is to address all members of the council, not just one member. And at this time, members of the public can make comments to the council.

Conroe Sadeghian-should make taxes fair. Need to work with the state to get money for more projects. Our properties have significantly increased in values over the last 5-6 years.

CA Anderlee-the state allows everyone to protest their value.

Dr. Matthew Tatarko-disagrees that the representatives of the city should not be able to protest their values.
