Following the reading of the official votes, Councilmember Steve Holland made the motion to adopt Resolution 1031-2020 canvassing the votes of the November 3, 2020 General and Special Elections, seconded by Councilmember John Claridge; all voted "Aye".

Tarrant County JP Chris Gregory administered the Statement of Elected Official and Oath of Office to Joe Ashton, Mayor, Yolie Rodriguez, Council Member Place 4 and Dan Chisholm, Councilmember Place 5. Mayor Earwood had the Certificate of Election presented to Joe Ashton, Yolie Rodriguez and Dan Chisholm.

Following the Oath of Office, City Manager Gregory presented to retiring Mayor Herman Earwood the city flag and card from the employees thanking the Mayor for his service. A special guest (Cameron Wheat) dressed up from the past presented the Mayor with the plaque from the city acknowledging 21 years of commitment to the City as Mayor and City Councilmember. Shirley Wheat recounted former memories how Mayor Earwood was instrumental in having the first fireworks show.

Several people including, but not limited to Councilmembers Holland, Chisholm, Claridge, Houk and newly elected Mayor Ashton expressed their heartfelt appreciation to Mayor Earwood for what he did for the City and recounted memories with him. Mayor Earwood spoke about what the City had accomplished during his tenure including having now a full-time fire department and a top of the line police department.
