8. DISCUSSION AND/OR ACTION FROM PRESENTATION BY DREW GRACE OF XEROX BUSINESS SOLUTION SOUTHWEST INCORPORATING A NEW PRINT MANAGEMENT PROGRAM ALONG WITH TECHNOLOGY ENHANCEMENTS TO INCREASE PRINTING PRODUCTIVITY AT A COST SAVINGS.

Drew Grace was present. A print analysis was conducted on all desktop printers. The current challenges are the current printers have a high operation costs, there are 16 different printer models which makes buying toner/ink expensive, when a printer is retired the pre-purchased ink is usually disposed of unless there are the same model of printers being used in another department, the current printers operate at a low speed and paper capacity, several workstations lack needed functionality to perform workflow needs; and language translation is either outsourced or done in house by other employees.

The benefits of this new program will update all printers to commercial printers, toner and ink are provided, increase productivity in several departments, reduces the different model types from 16 to 2, language translation app will allow translation in over 40 different languages and streamlines printer expenses into one invoice instead of multiple.

The current monthly expenses are \$1,657.07 and the new program cost is \$1,455.27 per month. The city can sell its current printers and ink that is on hand. This lease is a 60-month lease which is under the PACE Agreement (statewide bidding program). Will meet with CM Gregory and CS Luck every six months to evaluate if any changes need to be made.

CM Holland moved, seconded by CM Claridge to approve the contract with Xerox pending City Attorney approval. All voted "Aye".

Collier Albright was present. The survey was conducted today, and the construction crew is lined up. CM Holland suggested that the SUP is looked at in detail to make sure there are no issues. Giggles is no longer a school. In March 2018, the childcare investigators did not renew their day care license. The state was contacted, and it is a non-credited private school, and it is considered a treatment center.

CM Claridge moved, seconded by CM Rodriguez to approve the application of a specific use permit for the sale of alcohol mixed beverages at 5300 River Oaks Blvd. All voted "Aye".

11. CONSIDER APPROVAL OF RESOLUTION #1048-2021 REQUESTING TARRANT COUNTY GIVE STRONG CONSIDERATION FOR ACCEPTING PROJECT FOR STREET IMPROVEMENTS TO MERRITT STREET (FROM RIVER OAKS BLVD. SOUTH TO BARBARA ROAD), BARBARA ROAD (FROM CHURCHILL ROAD TO ROBERTS CUT OFF ROAD), ROBERTS CUT OFF ROAD, LONG AVENUE (1300-1800 BLOCKS), YALE STREET (FROM RIVER OAKS BLVD. NORTH TO INTERSECTION WITH ROBERTS CUT OFF ROAD), INTO ITS 2021 TRANSPORTATION BOND PROGRAM, IN ORDER TO OVERLAY CITY THOROUGHFARES.

Enclosed in the council packets are a breakdown of each street rehab cost in detail with some concrete repairs. Long Street still requires sewer upgrades, Roberts Cut Off Road from Ohio Garden Road to River Oaks Blvd. requires water main upgrades, and the engineering costs are not included. There was an error in the total rehab cost for all streets which brings the corrected total to \$2,834,929.37 with \$1,417,464.68 of that will be Tarrant County Bond participation. The Meandering Road project is separate from this. Provided in the packets are frequently asked questions from Tarrant County. This project is due to be turned in by noon this Friday.

CM Holland moved, seconded by CM Chisholm to approve Resolution #1048-2021. All voted "Aye".

12. CONSIDER APPROVAL OF RESOLUTION #1049-2021 CERTIFYING FINAL ACCEPTANCE OF THE PROJECT "WATER DISTRIBUTION SYSTEM IMPROVEMENTS CID-03 PRIORITY II PROJECT" UNDER THE TEXAS WATER DEVELOPMENT BOARD DRINKING WATER STATE REVOLVING FUND (DWSRF), TWDB PROJECT #62731.

Bill Lohrke was present. Presented is the Engineer Certification which will close out Phase II Water. Changes orders are done and has been inspected by all parties. This project was completed 2 ½ months early. On April 15th, we will start working on Phase III Water. The revised contract for Phase II is \$1,888,894.25. This Resolution will need to be sent to the Water Development Board. Timeline for Phase III will take about 6 months to complete.

CM Claridge moved, seconded by CM Rodriguez to approve Resolution #1049-2021. All voted "Aye".
