#### 1. CALL TO ORDER

With a quorum present, Mayor Pro Tem Joe Ashton called the Special Meeting of the River Oaks City Council to order at 7:02 p.m. on Tuesday, August 6, 2019 at the River Oaks Event Center, 5300 Blackstone Drive, River Oaks, Texas 76114.

CM Holland led the Pledges of Allegiance to the United States and the Texas Flags.

4. CONSIDER APPROVAL OF EMPLOYEE HEALTH, LIFE & MEDICAL INSURANCE RATES FOR PLAN YEAR OCTOBER 1, 2019 – SEPTEMBER 30, 2020 AS PRESENTED BY DAWN BRINSON, BRINSON BENEFITS.

Dawn Brinson was present. Mutual of Omaha, Guardian, Cobra and My Telemedicine rates remain the same except for the addition of Behavioral Health which is a confidential counseling service thru My Telemedicine at an additional cost of \$1.50 per month per employee. Blue Cross Blue Shield came in at an increase of 20.26%. City Staff is recommending changing carriers to United Health Care which offers a savings of 11.62%. This plan, the monthly premiums are decreased, the deductible remains the same, the copays to doctors, ER visits and Urgent Care have decreased. The only increase is the out of pocket maximum which will be \$7,150 instead of \$5,600. There are two choices from United Health Care which the city can offer to the employees at an additional cost: The first choice in which the city will pay the employee premium is in-network doctors only. The second choice in which the employee can pay the extra is in-network doctors and out of network doctors. The additional cost for employee only will be \$29.42 per month, employee + spouse \$64.72 per month, employee + children \$54.43 per month, and employee + family \$94.14 per month.

CM Holland moved, seconded by CM Houk to approve the Life, Dental, Vision and Medical plans as presented with choosing United Health Care as the new medical plan and offering the optional plan for out of network doctors to employees in which

the employee will pay for and adding behavioral health to the benefits. All voted "Aye".
