#### PERSONAL APPEARANCES AND/OR ITEMS REQUIRING COUNCIL APPROVAL/ACTION:

9. CONSIDER APPROVAL TO RENEW CONSTRUCTION PERMITS PURSUANT TO SECTION 105.3.2 "TIME LIMITATION FOR APPLICATION" & SECTION 105.5 "EXPIRATION" OF THE 2018 INTERNATIONAL BUILDING CODE FOR ARLYNN PURVIS AT 1155 GREENBRIER.

Arlynn Purvis was present. Mr. Purvis presented what he had left to do on the house. Thought it would be finished by the middle of August 2024. Mr. Purvis and the contractor were unaware the permits had expired and they have been actively working on the house.

CM Holland moved, seconded by CM Claridge to allow renewal of the permits and instead of normal expiration of six months, reduce it to three months and normal permit fees will be charged. All voted "Aye".

CONSIDER APPROVAL OF PROPOSAL FOR GENERATOR PREVENTATIVE MAINTENANCE.

This maintenance agreement is with the generators at City Hall, the Water Treatment Plant, and the Water Tower. The current agreement is with Cummins. Their services are not that good, and they are expensive. The contract expires the end of this year, and we will send a 30-day notice. Recommend going with the lower bid of \$2,980.00 with Cantwell Power Systems. References have been checked out.

CM Holland moved, seconded by CM Forester to approve the maintenance agreement with Cantwell Power Systems in the amount of \$2,980.00. All voted "Aye".

At 6:26 p.m., the Public Hearing continued.

The new owner on the house closed on October 3, 2024 but the tenants have not left the house. Pictures of the outside were shown. The new owner will need to submit a plan of action to the council. Council agreed to hold the Public Hearing open until November 19, 2024 at 6:00 p.m.

13. PUBLIC HEARING: IN ORDER TO RECEIVE PUBLIC INPUT ON SUBSTANDARD BUILDING ENFORCEMENT ACTION REGARDING STRUCTURE(S) LOCATED ON THE PROPERTY AT 5609 JAMES DR.

At 6:35 p.m., Mayor Houk opened the Public Hearing.

Myra Hodges, current owner and Jason Gleva, possible new owner was present. The tenant does not want to leave, and action is being taken to get the tenants out. It should take about two weeks to remove all the contents in the house. Nothing can be done until the tenants have been evicted. The city order has expired, and the new owner can come back to the City Council on November 19<sup>th</sup> and come in on November 20<sup>th</sup> to pull permits. The new owner will get with the building inspector so he can have access inside the house. Council agreed to hold the Public Hearing open until November 19, 2024 at 6:00 p.m.

CONSIDER APPROVAL OF ORDINANCE #1442-2024 AMENDING CHAPTER 13 "UTILITIES" ARTICLE 13.02 "UTILITY POLICY" OF THE RIVER OAKS CODE OF ORDINANCES (2020) AS AMENDED SPECIFICALLY IN SECTION 13.02.039 "RECONNECTION", SUBSECTION (e) INCREASING THE FEE TO \$25.00 WHEN THE CUSTOMER THAT HAS BEEN DISCONNECTED IS NOT PRESENT FOR RECONNECTION; AMENDING CHAPTER 13 "UTILITIES" ARTICLE 13.03 "WATER SYSTEM" OF THE RIVER OAKS CODE OF ORDINANCES (2020) AS AMENDED SPECIFICALLY UNDER SECTION 13.03.009 "METER DEPOSITS AND OTHER FEES" INCREASING ADMINISTRATIVE FEES AND SERVICE CHARGES; ESTABLISHING METER TEST FEES IN ACCORDANCE TO RULE § 24.169 OF THE TEXAS ADMINISTRATIVE CODE.

Since there are a lot of labor hours involved regarding disconnects for non-payment, would like to increase the admin fee from \$25.00 to \$35.00 or more.

Would like to increase the fee for door tags from \$15.00 to \$25.00. The customer is told someone must be at the house to reconnect the water. Trips made that no one is home is a waste of man hours.

Requesting for meter testing, requesting the customer be charged \$25.00 for residential customers.

# CM Forester moved, seconded by CM Holland to increase the administrative fee from \$25.00 to \$50.00 and to revisit everything when we switch to Incode 10. All voted "Aye".

16. CONSIDER APPROVAL OF ORDINANCE #1443-2024 AMENDING ARTICLE A.02 "SCHEDULE OF FEES AND CHARGES"; SPECIFICALLY IN SECTION A.02.001 "ESTABLISHED GENERALLY" SUBSECTION (c) "OTHER BUILDING INSPECTIONS AND FEES" UNDER (6) "PLAN REVIEW FEES" OF THE RIVER OAKS CODE OF ORDINANCES (2020) AS AMENDED THAT INCORPORATES FEES FOR SITE PLAN INSPECTIONS.

We do not charge for site visits. 80% of the site visits, permits are not pulled. If we charge \$25.00 for site visits, and if a permit is pulled, we can apply the \$25.00 towards the permit.

# CM Turner moved, seconded by CM Claridge to deny approval of Ordinance #1443-2024. All voted "Aye".

17. CONSIDER APPROVAL OF RESOLUTION #1133-2024 AMENDING THE EMPLOYEE POLICY MANUAL UNDER ARTICLE IV "COMPENSATION" SPECIFICALLY UNDER SECTION 4.03 "COMPENSATION FOR OVERTIME WORK", SUBSECTION (b) OVERTIME PAY FOR SWORN MEMBERS OF THE FIRE DEPARTMENT.

This cleans up the language in the personnel manual for the Fire Department that any hours over 106 in a pay period is overtime and FLSA allows any employee that takes leave, that it will not count against their overtime for the pay period. Currently, we are not counting it against their overtime, but the personnel manual doesn't say that.

CM Forester moved, seconded by CM Rodriguez to approve Resolution #1133-2024. All voted "Aye".

18. CONSIDER APPROVAL OF RESOLUTION #1134-2024 AUTHORIZING THE VOTE FOR THE ELECTION OF MEMBERS TO THE BOARD OF DIRECTORS TARRANT APPRAISAL DISTRICT.

CM Holland moved, seconded by CM Claridge to apply all three votes to Wendy Burgess. All voted "Aye".

### **OTHER ITEMS FOR DISCUSSION AND/OR ACTION:**

19. UPDATE ON SALE OF OLD STREET SIGNS AND DISCUSSION AND/OR ACTION ON STAFF RECOMMENDATION FOR THE REMAINING SIGNS.

There are around 120 signs left. City Employee Mik McGrath can melt down the remaining signs and make a star that says, "Retired City of River Oaks Street Signs" and it will not cost the city anything. We can continue selling the signs thru the end of this year and either melt the remaining ones down or scrap them.

# CM Claridge moved, seconded by CM Holland to extend selling the remaining street signs to the end of this year. All voted "Aye".

20. DISCUSSION AND/OR ACTION ON CREATING A TOURISM COMMITTEE TO QUALIFY EXPENDITURES OF HOTEL/MOTEL TAX REVENUES.

Council agreed that the City Council can decide what to spend this money on.
