### PERSONAL APPEARANCES AND/OR ITEMS REQUIRING COUNCIL APPROVAL/ACTION:

8. CONSIDER APPROVAL OF REQUEST FROM LUZ BARBOZA TO HOLD A 2024 CASTLEBERRY HIGH SCHOOL SENIOR CLASS PARADE AS A CITY SPONSORED EVENT.

Luz Barboza was present. Have done a parade in the past for the senior classes. Looking at May  $10^{th}$  or May  $20^{th}$ . The parade route was passed out and Chief Stewart did not have an issue with the route. This parade will only involve seniors and their vehicles will be registered and inspected before the parade. Figure about 20 vehicles in the parade. In the past, the parade was voted down due to the city not having enough police staff, CISD police wouldn't participate, and giving the city short notice. This year the Lions Club, CISD police, River Oaks police, and parents will be helping. Prefer to have the parade on Friday, May  $10^{th}$  at 6:00 p.m.

CM Turner moved, seconded by Mayor Pro Tem Claridge to approve May 10th, 2024 at 6:00 p.m. for the high school senior parade as a city sponsored event. All voted "Aye".

9. CONSIDER APPROVAL OF CHANGE ORDER TO THE LONG AVENUE STREET IMPROVEMENT PROJECT BY ADDING CURB AND GUTTER REPLACEMENT ON ALMENA FROM LONG TO BYRD DRIVE.

The Council approved the project and Almena was supposed to be included but it wasn't. This change order is for the curb and gutter on Almena for an additional amount of \$164,692.18. The current curb and gutter are damaged badly and won't allow the drainage to drain properly. The drainage on Almena drains on Long Avenue. The drainage will not be fixed at 100% on Long but it will be much better.

CM Forester moved, seconded by Mayor Pro Tem Claridge to approve the change order to the Long Avenue Street Improvement Project. All voted "Aye".

10. CONSIDER APPROVAL TO GO OUT FOR BIDS FOR INFORMATION TECHNOLOGY SUPPORT SERVICES FOR THE CITY'S COMPUTER SYSTEM TECHNOLOGY.

We have been with the same company for 15 years. We have met with several companies already. We plan on going out for bids in March.

# Mayor Pro Tem Claridge moved, seconded by CM Forester to approve going out for bids for Information Technology Services. All voted "Aye".

11. CONSIDER APPROVAL TO REQUEST ADDITIONAL DISCRETIONARY FUNDS OF THE COUNTY COMMISSIONER FROM THE 2006 TARRANT COUNTY TRANSPORTATION BOND FOR THE LONG AND ALMENA STREET IMPROVEMENT PROJECT.

What was originally submitted to the county was for paving. We have added the curb and gutter and want to ask the county for additional funds out of the 2006 Transportation Bond.

# CM Forester moved, seconded by Mayor Pro Tem Claridge to approve to request additional discretionary funds from the 2006 Tarrant County Transportation Bond. All voted "Aye".

12. CONSIDER APPROVAL OF RECOMMENDATION FROM THE RIVER OAKS STORM WATER TASK FORCE TO ADOPT THE STORM WATER LOGO AS THE OFFICIAL LOGO OF THE RIVER OAKS STORM WATER UTILITY SYSTEM.

Waiting on to other logos. This item is tabled.

13. CONSIDER APPROVAL OF CONTRACT TO ESTABLISH MEMBERSHIP WITH TARRANT AREA FOOD BANK FOR FOOD DISTRIBUTION TO THE EVENT CENTER FOOD BANK.

This contract is signed each year. We must pay for protein items. The other items are free. We have a volunteer that pays for this each month and is going to continue it. Every penny that he donates goes towards what is spent at the food bank. The city has a flat bed truck that we use for pick-up. The school will let us use their box truck if we need it. Each food bank serves 150-200 people.

Mayor Pro Tem Claridge moved, seconded by CM Turner to approve the contract with Tarrant Area Food Bank. All voted "Aye".

FOR DISTRIBUTION OF THE PERSONNEL POLICY TO ALL CITY EMPLOYEES; AND PROVIDING FOR AN EFFECTIVE DATE.

To comply with House Bill 471, this policy increased the compensation period from six months to one year. Telecommunicators are now included in the Mental Health Leave Policy. Firefighters will get Patriots Day, so we marked Labor Day as Patriots Day.

# Mayor Pro Tem Claridge moved, seconded by CM Forester to approve Resolution #1121-2024. All voted "Aye".

15. CONSIDER APPROVAL OF RESOLUTION #1122-2024 AUTHORIZING MEMBERSHIP IN THE ATMOS CITIES STEERING COMMITTEE; AND AUTHORIZING THE PAYMENT OF FIVE CENTS PER CAPITAL TO THE ATMOS CITIES STEERING COMMITTEE TO FUND REGULATORY AND RELATED ACTIVITIES RELATED TO ATMOS ENERGY CORPORATION.

This is approved every year and is very beneficial.

# Mayor Pro Tem Claridge moved, seconded by CM Forester to approve Resolution #1122-2024. All voted "Aye".

CONSIDER APPROVAL OF ORDINANCE #1413-2024 AMENDING ARTICLE 1.04 "BOARDS AND COMMISSIONS" DIVISION 1 "GENERALLY" SPECIFICALLY IN SECTION 1.04.006 "GENERAL RULES AND PROCEDURES" BY ADDING SUBSECTION (j) "DUTIES AND EXPECTATIONS OF A COUNCIL MEMBER LIAISON (NON-VOTING MEMBERS)"; DIVISION 2 "PLANNING & ZONING COMMISSION" BY INCORPORATING SECTION 1.04.036 "DUTIES AND EXPECTATIONS OF A COUNCIL MEMBER LIAISON (NON-VOTING MEMBERS)" AND DIVISION 3 "PARK BOARD" SPECIFICALLY IN SECTION 1.04.065 "GENERAL RULES AND PROCEDURES" BY ADDING SUBSECTION (j) "DUTIES AND EXPECTATIONS OF A COUNCIL MEMBER LIAISON (NON-VOTING MEMBERS)" THAT ESTABLISHES DUTIES AND EXPECTATIONS FOR CITY COUNCIL MEMBER LIAISONS AS NON-VOTING MEMBERS; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL PROVISIONS OF ORDINANCES IN THE CITY OF RIVER OAKS; PROVIDING THAT THE PHRASES, CLAUSES, SENTENCES, PARAGRAPHS, AND SECTIONS OF THIS ORDINANCE ARE SEVERABLE AND PROVIDING AN EFFECTIVE DATE.

Currently there are no rules and procedures for Council Liaison's that are on boards. Council Liaison's are not a member and cannot participate in the deliberation. The goal is to have something to look back on to make sure lines are not crossed. The Council Liaison's can say something like "this is my opinion" instead of "this is council's opinion". The board chairman's control the meetings and it is up to them to make sure no lines are crossed.

# CM Forester moved, seconded by Mayor Pro Tem Claridge to approve Ordinance #1413-2024. All voted "Aye".

17. CONSIDER APPROVAL OF ORDINANCE #1415-2024 AMENDING THE FY 2024 BUDGET BY EXPENDING FUNDS FROM THE COMMUNITY CENTER DOLLAR DONATION FUND IN ORDER TO PAINT AND REPLACE FLOORING IN THE BUILDING.

Asking for permission to go out for quotes on flooring and painting for the main room. The current floor has chunks missing and all the walls need to be repainted. A very nice projector

has been donated and the wall needs to be painted to project better. We cannot pass this Ordinance without an amount. No action taken.
