DISCUSSION AND/OR ACTION ON MAKING APPLICATION TO PARTICIPATE WITH THE TEXAS HISTORICAL COMMISSION IN THE MUSEUM ON MAIN STREET (MOMS), A TRAVELING EXHIBITION PROGRAM OF THE SMITHSONIAN INSTITUTION TRAVELING EXHIBITION SERVICE (SITES) DIVISION, WHICH AIMS TO ENGAGE SMALL-TOWN AUDIENCES AND REVITALIZE UNDERSERVED RURAL COMMUNITIES.

This is a traveling museum from the Smithsonian Institution. The application is intensive. They provide the museum content, and we can add River Oaks History. Required is an 800 square foot of space and the cost to River Oaks should be from \$5,000.00 to \$7,000.00. They do most of the work and provide training for our volunteers. They encourage us to partner with surrounding cities. It is possible that EDC and the Hotel/Motel Tax can fund this project.

10. CONSIDER APPROVAL OF THE GRANT APPLICATION WITH NCTCOG FOR SCRAP TIRE COLLECTION EVENT FUNDING (MARCH 1, 2025-APRIL 30, 2025).

Last year, we were approved for this grant, and we are approved again this year.

CONSIDER APPROVAL TO CALL A SPECIAL ELECTION ON NOVEMBER 4,2 205 UNIFORM ELECTION DATE FOR THE SALE OF REAL PROPERTY AT 5300 BLACKSTONE DRIVE COMPRISING 2.955 ACRES OF LAND LEGALLY DESCRIBED AS BEING LOTS A-1, B & C IN THE LEE ROGERS SUBDIVISION THAT HAS BEEN IDENTIFIED AS BEING PARK LAND THAT MAY NOT BE SOLD PURSUANT TO CHAPTER 253 OF THE TEXAS LOCAL GOVERNMENT CODE UNLESS THE ISSUE OF THE SALE IS SUBMITTED AND APPROVED BY THE VOTERS.

The city had a chance to put the event center, animal control, and public works on the YMCA property. The concept was done in April 2018. There have been several director changes at YMCA since then. The Event Center was appraised at \$3.2 million but with building apartments on the property. Some developers said you may get \$1 million for it if not building apartments.

Charles Richardson-the Event Center is not a great building, but a lot of people do pass by there and stop in to get information. Charles serves on the EDC board and voted to purchase the Baylor property. The idea was to put this property on the tax roll or turn this into an Event Center. It is bothersome that nothing has been done to the Baylor property.

Migalie Casteneda-graduated from CISD. Sees a lot of potential for the Event Cetner property. Need a place for the community to do things. Need to push things that make the community come together. There is potential for more park area like a pickle ball court and a walking area in that empty land area.

Citizen-loves the center. There are activities for all ages.

Citizen-loves the exercise classes the center has. All ages are welcome at the center.

Sarah Kelty (realtor)-has talked to a few people and would like to present offers to the council when one comes.

Shirley Wheat-we work Monday, Wednesday, and Friday from 9 am-3 pm. Heard comments on why more things are not offered at the center and it is because of the hours. When they do the jam sessions on Thursday nights, they don't get paid for it. It is volunteering. Currently trying to find a replacement band. CISD students help the center a lot. They are there every week and they learn a lot. The park equipment needs to be upgraded. The sand volleyball court costs a lot of money for upkeep. People feel safe after hours playing outside at the center.

CM Holland would like to look at animal shelter locations.

Council does not want to sell the Event Center.

Mayor Pro Tem Turner wants a needs assessment of the center to enhance it.

CM Rodriguez-grew up at the community center in the Northside area and there were a lot of activities. Our center needs more activities for our younger kids.
