# PERSONAL APPEARANCES AND/OR ITEMS REQUIRING COUNCIL APPROVAL/ACTION:

7. CONSIDER APPROVAL OF EMPLOYEE HEALTH, LIFE & MEDICAL INSURANCE RATES FOR PLAN YEAR OCTOBER 1, 2022 THROUGH SEPTEMBER 30, 2023 PRESENTED BY DAWN BRINSON, BRINSON BENEFITS.

Dawn Brinson was present. Several carriers declined to bid, and one carrier did not meet the bid deadline. Blue Cross Blue Shield and United Health Care did bid. Blue Cross came in at a 11.7% increase and was able to negotiate it down to a 5% increase. United Health Care came in at a significant increase. Our loss ratio was high. All benefits in the plan will remain the same. The other benefits (life, dental, Cobra, Benefit Bucks, Brinson, and Lyric) came in at a no rate change. Vision increased 5.59%.

CM Claridge moved, seconded by CM Rodriguez to approve the employee health, life & medical insurance rates as presented by Dawn Brinson. All voted "Aye".

# **OTHER ITEMS FOR DISCUSSION AND/OR ACTION:**

8. DISCUSS 2022 TAX RATE, TAK RECORD VOTE.

The city has three bonds: 2017A, 2017B and 2021 Street bonds. They can be secured by ad valorem taxes if we can not pay them out of our operating budgets. The total debt amount is \$901,560 with \$411,297 supported out of the water sewer fund. So that leaves \$490,263 that can be supported out of ad valorem taxes. The recommended 2022 voter approval tax rate is 0.777018/\$100. That is the maximum we can go but we can go down from that.

Craig Cunningham, Financial Advisor was present and explained the financial status of the city and how the ad valorem taxes can help pay for the current bonds the city has.

Mayor Pro Tem Chisholm moved, seconded by CM Rodriguez to support staff recommendation recommending a maintenance and operations tax rate at \$0.652999 and a debt rate of \$0.185427/\$100 for a total tax rate of \$0.838426/\$100. The Public Hearing for adopting the budget will be held on August 30<sup>th</sup> and the date for the vote on the tax rate will be on September 6<sup>th</sup>. The Council can vote on a lower maintenance and operations tax rate at that time. Mayor Pro Tem Chisholm, CM Rodriguez and CM Turner voted "Aye". CM Claridge voted "Nay". Motion passed.
