11. DISCUSSION AND/OR ACTION ON FY 2026 ROAD IMPROVEMENT PROJECT WITH TARRANT COUNTY PRECINCT 4.

This is for the 5300-5400 block of Castleberry Cut Off with a cost of \$104,258.92. We budgeted in the new budget \$40,000 for road repairs and we have \$162,835 in the street bond. Aware of the flood issue and the concern is water tearing up the new road.

# CM Holland moved, seconded by CM Forester to approve the 2026 Road Improvement Project as presented. All voted "Aye".

12. DISCUSSION AND/OR ACTION REGARDING THE GENERAL FUND OPERATIONAL 5-YEAR FINANCIAL PLAN AS PRESENTED BY THE CITY MANAGER.

A new 5-year plan was made because of additional costs in the new budget. Year 1: \$55,121 in the black; Year 2: \$66,935 in the black; Year 3: \$94,075 in the black; Year 4: \$80,664 in the black; and Year 5: \$37,911 in the black. The problem is not putting enough money back in reserves.

Added a 10% franchise fee for commercial accounts and added a \$2.00 rate increase for residential.
