**6. BUDGET ADOPTION: CONSIDER APPROVAL TO ADOPT A BUDGET FOR FISCAL YEAR 2026.**

Budget will not be adopted today. Need to schedule a Public Hearing for August 27, 2025.

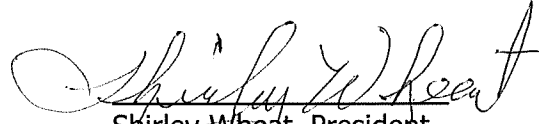
