1. CALL TO ORDER

out to all the residents, for a 24 page guide the estimated cost would be about \$1.30 per guide.

Board agreed to schedule a meeting with Kayla and to find out how much it would cost to send out the guides to residents.

8. UPDATE ON FIREWORKS SHOW ON JUNE 26, 2021.

Board agreed the cost of the fireworks this year will be \$5,300.00 which is the amount budgeted. Victory Church has agreed to donate \$2,650.00 towards this. The event will be held on June 26^{th} behind Victory Church. The church will hold a free event on the same day.
