1. CALL TO ORDER

With a quorum present, President Houk called the Regular Called Meeting of the Economic Development Corporation to order at 6:00 p.m. on Tuesday, August 25, 2025 at River Oaks City Hall, 4900 River Oaks Blvd, River Oaks, Texas 76114.

2. 4. CONSIDER APPROVAL OF MINUTES FROM THE AUGUST 11, 2025 REGULAR CALLED MEETING.

Member Richardson moved, seconded by Member Bybee to approve the Minutes of the August 11, 2025 Regular Called Meeting. All voted "Aye".

5. PUBLIC HEARING: IN ORDER TO RECEIVE PUBLIC COMMENTS AND TESTIMONY REGARDING RECOMMENDED APPROVAL OF FISCAL YEAR 2026 ECONOMIC DEVELOPMENT CORPORATION FUND OPERATING BUDGET (OCTOBER 1, 2025 – SEPTEMBER 30, 2026) PURSUANT TO THE LOCAL GOVERNMENT CODE, TITLE 12 "PLANNING AND DEVELOPMENT", CHAPTER 505 "TYPE B CORPORATIONS".

At 6:02 p.m., President Houk opened the Public Hearing.

Revenues: Sales Tax \$320,000; Interest \$13,000, Loan pay back \$3,600. Total Revenues \$336,600

Expenditures: Promotional Supplies \$5,000; Miscellaneous Supplies \$100; EDC Salary reimbursement \$135,532; Transit service \$21,000; Legal \$500; Publications \$300; Tarvel & Training \$2,500; Property Incentives/Businesses \$35,000; Banners \$10,000; Park improvements \$20,000; Matching Grant for parks \$75,000; City Promotional \$8,000. Total Expenditures \$312,932.00.

We have two more years on Nish and salary reimbursements. Need to add \$10,000 for the magazines in publications and need to increase the transit service to \$25,000. That will make a budget surplus of \$9,668 with the changes.

At 6:23 p.m., President Houk closed the Public Hearing.

6. ACTION FROM PUBLIC HEARING: CONSIDER APPROVAL OF THE REVENUES AND EXPENDITURES OF THE ECONOMIC DEVELOPMENT CORPORATION FUNDS AS PRESENTED FOR FISCAL YEAR 2026 OPERATING BUDGET BEING QUALIFIED BY THE ECONOMIC DEVELOPMENT CORPORATION AS APPROVED REVENUE AND EXPENDITURE PROJECTIONS FOR THE FY 2025-2026 BUDGET YEAR THAT WILL PROMOTE NEW OR EXPANDED BUSINESS DEVELOPMENT.

Member Richardson moved, seconded by Member Chisholm that pursuant to the Local Government Code, Title 12 "Planning and Development", Chapter 505 "Type B Corporations", the River Oaks Economic Development Corporation following a Public Hearing held on August 25, 2025 at 6:00 p.m. that was legally posted in accordance to the Open Meetings Act has qualified project expenditures in the fiscal year 2026 Economic Development Corporation budget related to business enterprise property incentives in the amount of \$35,000; a boulevard enhancement project for banners in the amount of \$10,000; a project related to public transportation in the amount of \$25,000, city promotional expenses in the amount of \$23,000 that promotes or develops new or expanded business enterprises that create or retain jobs and other professional services for salary reimbursement in the amount of \$135,532 in order to promote economic development within the city; a project related to recreational or community facilities for public park improvements in the amount of \$20,000; a project related to recreational or community facilities for park improvements in the amount of \$75,000 for a matching grant with the Texas Parks and Wildlife Department having been found suitable to promote or develop new or expanded business enterprises within the city that create or retain jobs. I further move to recommend that the River Oaks Economic Development Corporation approve the total revenue projections in the amount of \$336,600 and the total expenditure projections in the amount of \$326,932 as presented by the Executive Director to fund and operate the Economic Development Corporation for the Fiscal Year 2026 (October 1, 2025 through September 30, 2026). All voted "Aye".
