CALL TO ORDER

With a quorum present, President Houk called the Regular Called Meeting of the Economic Development Corporation to order at 6:02 p.m. on Tuesday, September 11, 2023 at River Oaks City Hall, 4900 River Oaks Blvd, River Oaks, Texas 76114.

2. INVOCATION

VP Richardson gave the Invocation.

3. PLEDGE OF ALLEGIANCE TO THE UNITED STATES FLAG AND THE TEXAS FLAG.

President Houk led the Pledge of Allegiance to the United States Flag and the Texas Flag.

President Houk thanked VP Richardson for filling in while he was out.

4. 6. CONSIDER APPROVAL OF MINUTES FROM THE AUGUST 22, 2023 SPECIAL CALLED MEETING.

Member Chisholm moved, seconded by Member Bybee to approve the Minutes of the August 22, 2023 Special Called Meeting. All voted "Aye".

PUBLIC HEARINGS/ACTION FROM PUBLIC HEARINGS:

7. PUBLIC HEARING CONTINUED FROM AUGUST 14, 2023: IN ORDER TO RECEIVE PUBLIC COMMENT AND TESTIMONY ON CONTINUING, RENEWING AND FUNDING THE AGREEMENT WITH FORT WORTH TRANSPORTATION AUTHORITY FOR BUS AND PARATRANSIT (MITS) SERVICE THROUGH MARCH 27, 2026.

Some board members have reached out to other companies if we decide to not to renew the contract. Have been unable to get firm prices on the services. Some members have employees or know people who ride the bus. Last year, we spent \$24,000.00 for the bus and for MITS. The person that got stranded; Detra was supposed to reach out to that person but has not yet.

JoAnn Butler-sees the bus always empty. Knew of a lady before COVID that would pick people up. There are also church people that would take people to the doctor.

Robert Brown-years ago, many voiced that they did not want the bus service. Does not see anyone on the bus. See a lot of homeless people who will get off at the QT. Recommends keeping the \$24,000.00 and beautifying the boulevard.

Royce Shields-River Oaks does not want the bus service. Doesn't see hardly anyone on it. People that represent people need to listen to people.

Member Holland-at first, a lot of people feared bringing people in. Was told by developers that the bus was needed. The reason EDC is paying for this service is because it is an allowable cost. If we terminate now, to get this service back will cost a lot more money.

VP Richardson-the concern is the MITS. There are five people in River Oaks that use the MITS on a regular basis. Westworth Village and Lake Worth does not contract with FWTA. If we terminate the agreement, we will have to pay to remove the shelter that is in front of City Hall, and it is an unknown figure and FWTA keeps the stop. VP Richardson read a letter to the board and requests EDC to terminate the agreement and look for other avenues of service. Feels this is a city issue not an EDC issue.

Member Knight-does not think we need the service if we find an alternative service. All our questions to Detra were not answered. This service does not bring people into this city to spend money.

At 7:22 p.m., President Houk closed the Public Hearing.

8. ACTION FROM PUBLIC HEARING: CONSIDER APPROVAL TO CONTINUE, RENEW AND FUND THE AGREEMENT WITH FORT WORTH TRANSPORTATION AUTHORITY FOR BUS AND PARATRANSIT (MITS) SERVICE THROUGH MARCH 27, 2026.

Member Chisholm moved, seconded by Member Holland that the River Oaks Economic Development Corporation finds that pursuant to the Local Government Code Title 12 "Planning and Development", Chapter 505 "Type B Corporations" that a project related to public transportation having been found suitable by the Board of Directors in order to continue, renew, and fund the agreement with Fort Worth Transportation Authority for

bus and paratransit (MITS) service through March 27, 2026 and further find that the project qualifies for the expenditures of EDC funds pursuant to Section 505.155 of the Texas Local Government Code and that the project having been found suitable to promote or develop new or expanded business enterprises within the city that create or retain jobs. And may agree to a termination if another service is found. Member Chisholm, Member Bybee, and Member Holland voted "Aye". President Houk, VP Richardson, and Member Knight voted "Nay". No action taken due to a tie vote.

Board agreed to hold a Special Meeting on September 25, 2023.

Very impressed with the store. Feels the store will not be opened until the end of October or the beginning of November.
