Member Holland moved, seconded by Member Chisholm to approve the Minutes of the September 11, 2023 Regular Called Meeting. All voted "Aye".

Items #7, #8, and #9 were discussed at the same time.

Other options if the board decides to not renew the bus service and MITS service:

- -Catholic Charities is \$37.00 for a one-way trip in Tarrant County. If outside of Tarrant County, the cost is \$75.00 per hour. Operations hours are only Monday thru Friday.
- -Paramount Transport is \$35.00 plus mileage charges.
- -Ride-n-Safe did not quote.

FWTA is \$40.33 per trip for paratransit only. Would remove the bus stops and shelters at no cost if we go with the paratransit. Operation hours are 7 am-11 pm seven days a week.

Concerns were if we stayed with MITS, they have left people stranded. If we get rid of the bus service, concerned about the ones who use the bus. Another concern is their customer service.

If we take no action tonight, we will continue paying to March 2024.

President Houk-have the same service thru March 2024 and at that point, cancel the bus service and use MITS only and use this time to get more information from other companies.

Member Chisholm-does not want to cancel the bus service.

Member Sanchez-would like to continue the bus service through March 2024 then cancel the bus service and use MITS only.

VP Richardson-prefers MITS only after March 2024 and can look at negotiating the bus service.

Member Holland-does not want to cancel the bus service.

Member Knight-There are so many other services that can get people to places. Supports the MITS.

Member Knight moved, seconded by Member Bybee that the River Oaks Economic Development Corporation finds that pursuant to the Local Government Code Title 12 "Planning and Development", Chapter 505 "Type B Corporations" that a project related to public transportation as a mobility-impaired transportation service having been found suitable by the Board of Directors for related transportation facilities pursuant to Section 505.152 "Projects related to Recreational or Community Facilities" of the Texas Local Government Code and therefore qualifies for the expenditures of EDC funds and further recommend that the City Council as the governing body authorized to enter into contracts and agreement on behalf of the City of River Oaks consider approving the Agreement with FWTA for Mobility-Impaired Transportation Service. And to leave the bus service on the table until March 2024 and try and renegotiate that service. All voted "Aye".
