ORDINANCE NO. 1257-2019

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIVER OAKS, TEXAS, AMENDING THE BOUNDARY OF REINVESTMENT ZONE NUMBER ONE, CITY OF RIVER OAKS, TO INCLUDE ADDITIONAL PROPERTY CONTAINING APPROXIMATELY 3.81 ACRES, PURSUANT TO CHAPTER 311 OF THE TEXAS TAX CODE, DESCRIBING THE BOUNDARIES OF THE ZONE, AND PROVIDING FOR AN IMMEDIATE EFFECTIVE DATE.

WHEREAS, the City of River Oaks, Texas (the "<u>City</u>"), pursuant to Chapter 311 of the Texas Tax Code, as amended (the "<u>Act</u>"), may designate a geographic area within the City as a tax increment reinvestment zone if the area satisfies the requirements of the Act; and

WHEREAS, pursuant to and as required by the Act, the City Council of the City (the "<u>City Council</u>") prepared a *Reinvestment Zone Number One, City of River Oaks Preliminary Project and Finance Plan* (the "<u>Preliminary Project and Finance Plan</u>") for Reinvestment Zone Number One, City of River Oaks (the "<u>Zone</u>") defining the boundary of the Zone at approximately 152.97 acres as described and depicted in **Exhibit A** attached hereto (the "<u>Property</u>"); and

WHEREAS, on November 15, 2018 the City Council approved Ordinance No. 1208-2018, approving the Preliminary Project and Finance Plan and creating the Zone; and

WHEREAS, the City Council, pursuant to the Act, may amend the boundary of the Zone if the area satisfies the requirements of the Act; and

WHEREAS, a notice of public hearing on amending the Zone to include approximately 3.81 acres, as described and depicted in **Exhibit B** attached hereto (the "<u>Additional Property</u>"), was published in the Fort Worth Star Telegram, a newspaper of general circulation within the City on November 27, 2019, which date is not later than the seventh day prior to the public hearing held on December 10, 2019; and

WHEREAS, on December 10, 2019, the City Council held a public hearing to consider an amendment to the Zone to include the Additional Property; and

WHEREAS, at the public hearing on December 10, 2019, interested persons were allowed to speak for or against including the Additional Property in the Zone, the proposed amended boundaries of the Zone, and the concept of tax increment financing, and owners of property in the Additional Property were given a reasonable opportunity to protest the inclusion of their property in the Zone; and

WHEREAS, the City has taken all actions required to amend the Zone including, but not limited to, all actions required by the Act, the Texas Open Meetings Act, and all other laws applicable to the amendment of the Zone.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RIVER OAKS, TEXAS:

SECTION 1. DESIGNATION OF THE AMENDED ZONE.

Pursuant to the authority of, and in accordance with the requirements of the Act, the City Council hereby amends the Zone to include the Additional Property, as described and depicted in **Exhibit B** attached hereto.

SECTION 2. SEVERABILITY.

If any provision, section, subsection, sentence, clause or phrase of this Ordinance, or the application of same to any person or set of circumstances, is for any reason held to be invalid, the validity of the remaining provisions of this Ordinance or their application to other persons or sets of circumstances shall not be affected thereby, it being the intent of the City Council in adopting this Ordinance that no provision of this Ordinance shall become inoperative because of the invalidity of another provision; and, therefore, all provisions of this Ordinance are declared severable for that purpose.

SECTION 3. OPEN MEETINGS.

It is hereby found, determined, and declared that sufficient written notice of the date, hour, place and subject of the meeting of the City Council at which this Ordinance was adopted was posted at a place convenient and readily accessible at all times to the general public at the City Hall of the City for the time required by law preceding its meeting, as required by the Texas Open Meetings Act, Chapter 551 of the Texas Government Code, as amended, and that this meeting has been open to the public as required by law at all times during which this Ordinance and the subject matter hereof has been discussed, considered and formally acted upon. The City Council further ratifies, approves and confirms such written notice and the contents and posting thereof.

SECTION 4. EFFECTIVE DATE.

This Ordinance shall take effect immediately upon its passage as provided by law.
