

ORDINANCE # 1273-2020

AN ORDINANCE OF THE CITY OF RIVER OAKS AMENDING THE 2019-2020 FISCAL YEAR E.D.C. FUND BUDGET DUE TO AN UNPLANNED EXPENDITURE INCREASING THE BUDGET FOR PURCHASING REAL PROPERTY AT 1512 SHENNA BLVD; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on September 5, 2019 the City Council of the City of River Oaks, Texas approved Ordinance # 1244-2019, adopting the operating budgets of the City for the fiscal year beginning October 1, 2019 and ending September 30, 2020; and

WHEREAS, the Economic Development Corporation has qualified a project of \$10,000 or more related to business development involving the purchase of land, structure and improvements described as being Lot 10, Block 5 in the Rockwood Terrace Addition otherwise known as 1512 Shenna Boulevard in River Oaks, Tarrant County, Texas found by the board of directors to promote new or expanded business development for businesses to locate within the corporate limits of the city pursuant to Section 505.158 of the Local Government Code in the Fiscal Year 2019-2020 Budget in the amount of \$196,928.20; and

WHEREAS, at the EDC Special Meeting on January 28, 2020 the board approved to ratify the unplanned expenditure with the adoption of Resolution 998-2019 following the second reading by the City Council on January 28, 2020 including reimbursing the broker \$1,110 for the pre-paid earnest fees; and

WHEREAS, the City Council after a thorough research of the budget determined that this unplanned additional expenditure be approved by expanding the FY 2020 E.D.C. Fund Budget an additional \$198,038.20 in order to cover the closing costs associated with the purchase of real property and that the Budget be amended increasing the unappropriated balance of the 2019-2020 budget.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RIVER OAKS:

SECTION 1.

That the 2019-2020 E.D.C. Budget of the City of River Oaks is hereby amended by an additional **\$ 198,038.20 dollars** from the unappropriated balance of the **E.D.C. Fund** and increasing the following account as follows:




SECTION 2.
