ORDINANCE # 1274-2020

AN ORDINANCE OF THE CITY OF RIVER OAKS AMENDING THE 2019-2020 FISCAL YEAR WATER FUND BUDGET TRANSFERRING FUNDS FROM THE WATER DISTRIBUTION DEPARTMENT TO SEWER DEPARTMENT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on September 5, 2019 the City Council of the City of River Oaks, Texas approved Ordinance No. 1244-2019, adopting the budget for the fiscal year beginning October 1, 2019 and ending September 30, 2020; and

WHEREAS, the city council approved the expenditure in the FY 2020 Water Fund Budget to purchase special purpose equipment in the Water Distribution Department # 02-531-5462 in the amount of \$3,278.00; and

WHEREAS, the city council approved the expenditure in the FY 2020 Water Fund Budget to purchase special purpose equipment in the Sewer Department # 02-532-5462 in the amount of \$10,383.00; and

WHEREAS, due to the water and sewer improvements within the city it has been discussed that the public works department procure asphalt equipment contained within one compact unit with a larger carrying capacity that square holes, patch and seal in order to expedite street repairs especially after the installation of utility lines; and

WHEREAS, in lieu of purchasing pumps or hydrovac trailer, it is the recommendation of the public works director that it would be more beneficial to the city to purchase a pothole patch truck that can be used to make street repairs; and

WHEREAS, asphalting street cuts is both a water and general fund expenditure and has been budgeted for out of both funds for many years; and

WHEREAS, the City of McKinney placed up for auction a pothole patch truck and the River Oaks public works superintendent after a thorough inspection of the truck and its numerous attachments found the truck to be in good quality working condition and therefore was authorized to made a bid to purchase the truck in the amount of \$12,700, which ended up being the winning bid; and

WHEREAS, the City Council after due and careful consideration finds that this being only a transfer of funds already allocated that the expenditure will not expand the 2019-2020 Fiscal Year Water Fund Budget as originally adopted and as amended.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RIVER OAKS:

SECTION 1.

That the 2019-2020 Operational Budget of the City of River Oaks is hereby revised by transferring funds from within the Water Fund in Account 02-531-5462 "Special Purpose Equipment" to Account # 02-532-5462 "Special Purpose Equipment" to purchase an asphalt patch truck as herein itemized below:
