Lions Soccer Takes Sole Possession of District Lead



A championship-caliber atmosphere filled W.O. Barnes Stadium on Friday, Feb. 20, as the Castleberry High School Lions squared off against the Eagle Mountain Knights in a pivotal District 8-4A showdown. With the first half of district play coming to a close, the stakes could not have been higher: first place was on the line.

Eagle Mountain entered the night with an impressive 8-1-2 overall record and a perfect 4-0 mark in district play. The Knights

had established themselves as one of the teams to beat, combining disciplined defense with timely scoring. Castleberry, meanwhile, brought a 7-7-3 overall record into the contest but had quietly built momentum in district competition. The Lions were 3-0-1 in district and riding a string of strong performances that suggested they were peaking at the right time.

The two teams were remarkably similar on paper. Over the course of the season, they had faced *(continued on page 5)*

City to Offer Free Tire Pickup to Reduce Mosquito Breeding

City officials are urging residents to clear out discarded tires to help reduce mosquito breeding as warmer weather approaches.

Discarded tires left in yards can collect standing water, creating an ideal environment for mosquitoes to lay eggs. To address the issue, the city is offering free tire collection for residential customers from March 1 through April 30, 2026.

Residents may place up to four used tires at the curb on their regular Wednesday bulk collection day. The city will collect and dispose of the tires at no charge during the limited-time program.

Households with more than four tires to discard are asked to contact the Public Works Department to schedule a special pickup

by calling 817-626-5421, ext. 332. Residents also may call to request pickup service. Otherwise, Public Works crews will collect tires placed at the curb on bulk collection day.

The free collection service is available to residential customers only. The city will not collect tires from businesses, as commercial waste disposal is handled through a contracted commercial hauler.

City officials encourage residents to take advantage of the program before it ends April 30.

Spring Clean Up Month Returns to River Oaks

River Oaks Event Center Food Bank Distribution Dates

Residents will have the opportunity throughout April to de-clutter their homes and properties as part of the City of River Oaks' annual Spring Clean Up Month.

The City of River Oaks hosts Food Bank distribution days on the second and fourth Fridays of each month at the River Oaks Event Center, located at 5300 Blackstone Drive.

From April 1 through April 30, the city will collect a wide range of unwanted items placed at the curb on residents' regular trash and bulk pickup days. City officials are encouraging homeowners to take advantage of the program to clear out garages, yards and storage areas as warmer weather sets in.

The last Food Bank distribution date for the month of February is Friday, Feb. 27.

During Clean Up Month, crews will collect tree limbs, brush, logs, debris, junk, garbage and general household trash placed at the curb. The initiative is designed to help residents dispose of items that may not fit in regular trash bins while improving neighborhood appearance and safety.

Participants are asked not to line up before 8:30 a.m. and to follow the new designated traffic route. Drivers should remain in their vehicles throughout the process and avoid blocking residential driveways or cross streets to ensure access for police and emergency services.

Residents are reminded to place all items at the curb on their normal trash and bulk collection day to ensure pickup. Items should be organized neatly to allow crews safe and efficient access.

The service is intended to help residents maintain clean, safe properties while preventing illegal dumping and potential health hazards.

First Monday Quilt Club to Meet March 2

On the first Monday of every month, laughter, conversation and the steady hum of sewing machines fill Bethany Christian Church in White Settlement as volunteers gather not just to quilt, but to change lives.

The First Monday Quilt Club meets from 9 a.m. to noon at the church at 1500 Meadow Park Drive, bringing together volunteers who create handmade quilts and blankets for those who need comfort most.

The group's next meeting is set for Monday, March 2. Instead of a potluck lunch, participants are asked to bring brunch or snack items to share.

The club is part of Project Linus, a non-profit organization whose mission is to provide love, warmth and a sense of security to children who have experienced trauma, tragedy or serious illness.

Locally, the volunteers serve as the Tarrant County Chapter of Project Linus, creating blankets that are distributed to children throughout the area.

Their work does not stop there. The group also makes coverlets for veterans, nursing home residents and people experiencing homelessness. As needs in the community continue to grow, so does the demand for these handmade gifts of comfort.

Organizers say they are especially in need of volunteers with portable sewing machines to help assemble quilts, but stress that no experience is required.

"There is a place for everyone," organ-

izers said. Volunteers can help by sewing, tying knots, crocheting, sorting fabric or simply lending a helping hand and good spirit. Along the way, many find not only a meaningful way to serve, but lasting friendships as well.

High school students can earn community service hours by participating, and all materials, including fabric, batting, thread and yarn, are provided. Donations of supplies or monetary contributions to help purchase materials are also welcome and appreciated.

Those interested are encouraged to come for the fellowship and stay for the joy of making a difference, one stitch at a time.

six common opponents. Both squads fell to Alvarado by identical 1-0 scores. Both defeated Kennedale, Lake Worth, Springtown and CATCCN. The only separation in district play came in their respective matchups with Lake Dallas: Castleberry battled to a scoreless 0-0 draw, while Eagle Mountain secured a narrow 2-1 victory. That slim difference set the stage for Friday's clash, with the winner poised to claim sole possession of first place heading into the second round of district competition.

From the opening whistle, the game lived up to its billing.

The first half unfolded as a defensive battle, with both teams playing aggressively and limiting clear scoring opportunities. The Lions generated the first shot on goal when freshman Israel Arriaga Reyes fired a shot at the 36:35 mark that sailed just over the crossbar. It was an early signal that Castleberry would not be intimidated by the moment.

Just minutes later, however, momentum shifted. At the 32:34 mark, a foul call against the Lions resulted in a penalty kick opportunity for the Knights. The call drew some debate from the home crowd, but Eagle Mountain capitalized, converting the penalty to take a 1-0 lead.

Castleberry responded with composure. At 31:35, sophomore Cristian Gutierrez launched a free kick from 28 yards out, but the Knights' goalkeeper was there to make the stop. Eagle Mountain threatened again midway through the half with shots at 22:30 and 20:30, yet each attempt was turned away by senior goalkeeper Caleb Castaneda, whose steady play kept the Lions within striking distance.

As the half wore on, Castleberry continued to search for an equalizer. Gutierrez delivered another dangerous free kick at the 8:02 mark, once again handled by the Knights' keeper. Senior Uriel Pereyra had the Lions' final shot on goal of the half at 2:43, but a defender stepped in to block the attempt. When the halftime whistle sounded, Eagle Mountain held a slim 1-0 advantage, courtesy of the penalty kick.

If the first half belonged to the defenses, the second half belonged to the Lions.

Eagle Mountain opened the period with renewed urgency, registering two early attempts, one wide right at 38:28 and another at 33:22 that was smothered by Castaneda. But after weathering that brief push, Castleberry seized control of the match.

The Lions began to press higher up the field, forcing turnovers and keeping sustained pressure on the Knights' back line. The breakthrough came at the 26:52 mark. Senior Daniel Bustamante sent a shot from the left side that ricocheted off a defender in front of the goal. Junior Sebastian Garcia reacted quickly, pouncing on the loose ball and driving it into the net to tie the game 1-1. The home crowd erupted as momentum swung decisively in Castleberry's favor.

Eagle Mountain managed one more long free kick at 22:15, but Castaneda calmly secured it. From that point on, the Knights struggled to generate meaningful offensive opportunities.

Castleberry continued to attack. At 18:25, freshman Jorge Hernandez nearly gave the Lions the lead with a header that drifted just wide right. Moments later, Reyes delivered a highlight-reel strike. At the 16:50 mark, he maneuvered past defenders and unleashed a skillful shot that sailed beyond the goalkeeper and into the upper corner of the net. The Lions had their first lead of the night, 2-1.

The energy at W.O. Barnes Stadium surged.

Castleberry did not sit back. Junior Giovanni Saldana narrowly missed at 14:55, and his follow-up attempt at 9:55 was turned away by the Knights' keeper. Then, at 8:42, the Lions effectively sealed the victory. Hernandez found space approximately 20 yards from goal and fired a shot that curled into the left corner of the net, extending the lead to 3-1.

Even with a two-goal cushion, the Lions remained aggressive. Gutierrez and Pereyra each had additional shots in the closing minutes, narrowly missing opportunities to add to the tally. When the final whistle blew, Castleberry players celebrated a hard-earned 3-1 victory in front of an enthusiastic home crowd.

The win marked a significant milestone for the Lions. By defeating the previously undefeated Knights in district play, Castleberry moved into sole possession of first place in District 8-4A. After the first round of district competition, the Lions stand at 4-0-1, while Eagle Mountain drops to second at 4-1.

More importantly, the victory underscored Castleberry's growth over the course of the season. A team that battled through early challenges has found its rhythm at the most critical juncture.

The Lions displayed resilience after falling behind, depth in their scoring attack and defensive toughness anchored by Castaneda in goal.

With the second round of district play set to begin, Castleberry now controls its own destiny. The Lions will play at home Feb. 27 when they host Lake Worth at 5:30 p.m.

If Friday night was any indication, the road ahead promises more excitement. For now, the Lions sit atop the district standings and firmly in the driver's seat.

Pulaski's Legacy Endures as Nation Marks 250th Anniversary

As the nation prepares for the 250th anniversary of independence, Americans look with renewed interest to the lives of men and women from the Revolutionary Era. Among those was Count Casimir Pulaski, a man who came across the seas to aid the new United States in its hour of need. The Polish general arrived in the United States during the American Revolution, trained American troops, and gave his life for the freedom of the new land. Pulaski became a hero for the generation of men who fought for American independence.

Casimir Pulaski was born in March 1746 in Warsaw, the capital of what was then the Confederation of Poland and Lithuania. His family was part of the Polish nobility, and his family made sure he received the best education. In 1762, at the age of 16, he entered the military, serving as an aide to the Duke of Courland, a prestigious posting.

Poland had once been the most powerful nation in East Europe; but now its power was on the decline, and it was under increasing threat from Russia. In 1764, King Stanislaw II came to power in Poland, and Russia increasingly worked its tendrils into the country, eventually forcing Poland to allow Russian troops to be stationed there. Believing that Russia must be stopped and that the new king was betraying the country, Pulaski and his father joined the Bar Confederation in 1767 to fight against Russia, in defiance of the king. Though only 21, Pulaski was made a colonel in charge of a cavalry unit and worked to convince other Polish troops to join their cause against Russia.

By early 1768, Pulaski and the Bar Confederation were fighting both Russian troops and the Polish king's army. He won several impressive victories at first. By June, he was briefly captured by the Russians but later exchanged for another captive. He quickly developed a reputation for daring raids and sometimes disobeying orders when he saw a bigger military opportunity. He won several battles against more numerous Russian forces and earned a respected reputation across Europe. Eventually, he was promoted to general. However, in spite of several dramatic victories and surviving several long sieges, the Bar Confederation was steadily losing ground. In May 1772, Pulaski was forced to leave Poland, and the effort against Russia collapsed. Russia would seize a third of Poland's territory, the first of several partitions of the country.

Russia forced King Stanislaw II to order his parliament to ratify the partition of Poland in 1772. Several months later, Pulaski was convicted by the assembly for attempting to assassinate the king. Eventually, Russia would swallow all of Poland. In the meantime, Pulaski was on the run.

Pulaski was in France by 1775. His attempt to join the French army was rejected, and he fell deeply into debt. At one point, he was imprisoned for failure to pay these debts. In 1777, he met Ben Franklin, who was then serving as ambassador to France. Pulaski was inspired by the American cause of freedom against a more

powerful foe. Impressed by Pulaski's experience, Franklin encouraged the general to go to America.

In July 1777, Pulaski arrived in Massachusetts. He presented himself in a letter to Gen. George Washington, famously declaring, "I came here, where freedom is being defended, to serve it, and to live and die for it." He joined Washington in Pennsylvania and quickly began advising Washington on new cavalry tactics. At the Battle of Brandywine in September, Washington's forces were being overwhelmed, and the British were about to cut off the American retreat. Pulaski leapt into action, gathered a few of Washington's men, and led a daring cavalry charge to broke through the British advance, allowing the faltering Continental troops to get to safety.

During the bitter winter at Valley Forge in 1777, Washington allowed Pulaski to reorganize the cavalry forces for the Continental Army. Pulaski often clashed with other officers. His European command style and difficulty speaking English made it difficult to lead American troops. By 1778, he was promoted to brigadier general in the Continental Army and allowed to form his own cavalry unit. He soon had a unit of hundreds of men, both immigrant and American-born. He was known for his strict discipline but also for clever tactics that even won the grudging respect of British generals. Military historians have since credited Pulaski with the birth of the American cavalry.

By May 1779, Charleston, South Carolina, was on the brink of capture by the British. Pulaski arrived and decided to break the siege of Charleston by leading a raid on nearby Savannah, Georgia, which had fallen a year earlier. His attempt pushed back the British but cost many of his fellow cavalymen. Nevertheless, they managed to capture a nearby British outpost. In October, with the arrival of French reinforcements, Pulaski decided to try to retake Savannah once again. Again, they met heavy resistance. The French lines broke during the battle, and Pulaski rode to rally the troops. In the chaos, he was cut down by British fire. He died two days later at age 33.


Seven states have named counties after him, including Georgia, Missouri, Arkansas, and Virginia. He has been honored in many other ways.

In 1824, the Marquis de Lafayette, the French general who had fought with American forces during the American Revolution and one of the last surviving generals from the war, laid the cornerstone for the Pulaski Monument in Savannah.

The former community of Pulaski in Panola County was named for him in the 1840s. In 1929, Congress named October 11 as General Pulaski Memorial Day.

In 2009, he was posthumously made a United States citizen, one of only a handful of people so honored.
