



SPECIAL AFTER-HOURS CONSTRUCTION PERMIT OF BUILDINGS

Sec. 8.03.008 Erection, excavation, demolition, etc., of buildings at night

The erection, including excavation, demolition, alteration or repair work on any building when in the opinion of the chief of police violates the city's noise ordinance in that there exists after 10:00 p.m. and before 6:00 a.m. an unreasonably loud, disturbing, unnecessary noise which causes material distress, discomfort or injury to persons of ordinary sensibilities in the immediate vicinity thereof and is therefore declared to be a nuisance and is prohibited. Any noise of such character, intensity and continued duration, which substantially interferes with the comfortable enjoyment of private homes by persons of ordinary sensibilities, is also declared to be a nuisance and is prohibited.

If the Police Chief finds that construction work on any building doesn't violate the noise ordinance or interferes with the comfortable enjoyment of private homes by persons of ordinary sensibilities and is therefore not deemed a nuisance, the owner or contractor may file an application to obtain a special permit in order to perform necessary construction work after hours between the hours of 10:00 p.m. to 6:00 A.M. by completing the form below:
