MAJOR DUTIES:

- Operate Water Treatment Plant on scheduled shifts
- Perform preventative maintenance on all equipment and piping
- Perform preventative maintenance on all pumps and motors
- Check and maintain chemical pumps to ensure proper pump operations
- Monitor chemical supply and report levels to Plant Superintendent
- Keep all areas of the treatment plant, tank storage area and booster station clean, grass cut and general condition in top condition
- Perform janitorial work in keeping the Operations Room, Laboratory, Restroom, Pipe Galley, Chemical Room, Raw Water Pump House and Loading Dock clean
- Fill out daily reports for the operation of the plant
- Take and record samples in accordance to the T.C.E.Q. rules and regulations
- Read meters daily on Raw and Finished Water
- Daily Inspection of Raw Water Intakes at the Lake
- Monitor water levels of the raw, filtered and finished waters
- Perform routine jar tests
- Monitor PH, Hardness, Alkalinity, Turbidity, Total Chlorine Residuals, Water Temperature and Ammonia Levels every four hours during plant operations
- Perform any other necessary tests to ensure good water quality
- Backwash filters every 100 hours or sooner if necessary
- Drain and clean Clarifier on a routine basis
- Inspect Storage Tanks daily
- Provide potable and safe water to the public

JOB COMPLEXITY:

- Performs routine operations
- Report any problems or plant malfunctions to the Plant Superintendent
- Perform sensitive testing on raw, filtered and finished water
- Record plant readings and testing results on the proper reporting forms
- Perform preventative maintenance on all operational equipment
- Follow Plant Monitoring Plan
- Protect from Back siphonage
- Practice Water Conservation
- Perform all duties safely using the proper safety equipment and clothing
- Subject to after hours call back in the event of a plant malfunction

RESPONSIBILITY:

- Be on time
- Report any problems prior to shift change
- Report Security Breaches immediately to the Police Department
- Report violations to the Plant Superintendent
- Monitor security to plant property and buildings

- Use protective safety equipment issued including, but not limited to hard hats, eye glasses, shields, air respiratory protection, gloves and ear plugs.
