4. CONSIDER APPROVEL OF MINERAL LEASE WITH CHESAPEAKE EXPLORATION, LLC INVOLVING TRACTS OF LAND BELONGING TO THE CITY OF RIVER OAKS AS PRESENTED BY KYLE SMITH OF TWO ROCKS, INC.

Kyle Smith with Two Rocks said there were small amount of tracts along River Oaks Blvd that was not included in the original proposal. There are also tracts including Carswell Access Road, 1114 Oxford Street and other small tracts of land on Club Oak Drive that the mineral rights also belong to the City. The total acreage of both proposals is 5.0271 acres @ \$2500 per acres amounting to being \$12,567.75 for the City. It is a 2-year term lease with 25% royalties. If accepted, proposal is ready for signatures and a check will be given to the City for \$12,567.75.

Member Crews moved, seconded by Mayor Pro Tem Gordon to approve the mineral lease agreement as presented. All voted "aye".
