ZA Gregory presented the request of Giggles Therapy to construct a 120 square foot metal accessory building on the property that is located in "C-1" (Commercial) Zoning District at 905 Roberts Cut Off. According to Section 14 D.7 of the Zoning Ordinance, an approved site plan that contains information required in Section 25 shall be a prerequisite for issuance of a building permit in a "C-1" Zoning District. In addition, Section 14 D.1 requires that all exterior building walls must at least 75% masonry.
