At 7:06 p.m., Mayor Ashton opened the Public Hearing.

This is regarding the Moratorium Ordinance.

Attached is what the Planning & Zoning Commission approved and recommended to the City Council.

Royce Shields, the Zoning Board of Adjustments Chairman was present. The state puts the hardships on. Mayor Ashton mentioned that White Settlement has a "special exception". If someone wants for example a carport, letters are sent out to neighbors. If the neighbors do not object, they can build it. If they do object, it will go before the Zoning Board of Adjustments, not for a variance but for the objection.

The Planning & Zoning Commission wanted a 15' set back on carports on a corner lot, and the Zoning Board of Adjustments wanted a 20' set back. Council agreed to a 15' set back on carports on corner lots.

With both banks closed in River Oaks, one bank has left their ATM machine for now. There is one business that does have an ATM inside their business. Council agreed to not to restrict free standing ATM's.

There are some undesirable tire shops around. If we restrict tire shops now and if a major brand tire shop wants to come into River Oaks in the future, we can amend the ordinance to allow it. If for example an existing tire shop closes and a new owner wants to open another tire shop, the new owner will have to register as a legal non-conforming. But the new owner cannot expand that business.

At 7:43 p.m., Mayor Ashton closed the Public Hearing.

7. **ACTION FROM PUBLIC HEARING:** IN ORDER TO CONSIDER APPROVAL OF **ORDINANCE # 1331-2021** AMENDING THE COMPREHENSIVE ZONING ORDINANCE # 1286-2020 SPECIFICALLY REVISING SECTION 14 "C-1 COMMERCIAL DISTRICT - (NEIGHBORHOOD RETAIL)", SECTION 15 "C-2 COMMERCIAL DISTRICT", SECTION 16 "C-3 COMMERCIAL DISTRICT" AND SECTION 22.A "AUTHORIZED ACCESSORY USES" # 5 "CARPORTS SUBJECT TO THE FOLLOWING REQUIREMENTS" (ZONING CASE PZ 2021-0012).

CM Claridge moved, seconded by Mayor Pro Tem Houk to approve Ordinance #1331-2021 with these changes: to not restrict ATM machines and allow them; and to allow a 15' setback on carports on corner lots. All voted "Aye".
