PERSONAL APPEARANCES AND ITEMS REQUIRING COUNCIL APPROVAL/ACTION:

8. CONSIDER APPROVAL OF REQUEST FROM APRIL & STEVEN COURTNEY AT 1817 MELBA COURT TO ADJUST WATER BILL DUE TO A LEAK.

April & Steven Courtney were present. Was unaware that there was a toilet leak in their second bathroom. Was told a note was put on the gate but it must of blew off. Blythe Reaves, Utility Billing Coordinator called them a few weeks later and told them about a possible leak. CM Gregory figured the adjustment of \$370.78 which calculates it the way Fort Worth Water does when they do leak adjustments. A pay arrangement was made but for the past bills due to loss of income because of the COVID-19. The policy presented in Item #11, the customer would have to maintain 12 months of service in order to qualify for a leak adjustment.

Mayor Pro Tem Ashton moved, seconded by CM Claridge to direct staff to follow policy for Item #8 at 1817 Melba Court with using 12 months of service to calculate the adjustment and this policy will go with the address, not the owner. All voted "Aye".

9. CONSIDER APPROVAL OF REQUEST BY THE RIVER OAKS EVENT CENTER TO ALLOWING THE RETURN OF COMMUNITY RENTALS.

Staff would have to do deep cleaning after each rental and feels right now it is not a good idea to open it up to rentals.

CM Chisholm moved, seconded by CM Houk to deny the request of allowing rentals to return at the Event Center. All voted "Aye".

ORDINANCES / RESOLUTIONS REQUIRING COUNCIL APPROVAL/ACTION:

10. CONSIDER APPROVAL OF ORDINANCE #1294-2020 AMENDING ARTICLE 4.05 "YARD SALES" SPECIFICALLY UNDER SECTION 4.05.007 "REVOCATION AND REFUSAL OF PERMIT" REVISING SECTION 4.05.007(2).

This is a change in terminology from "conviction" to "violation". A lot of people are not pulling up their signs, not getting their signs approved, etc.

CM Holland moved, seconded by CM Chisholm to approve Ordinance #1294-2020. All voted "Aye".

11. CONSIDER APPROVAL OF ORDINANCE #1295-2020 AMENDING ARTICLE 13.02 "UTILITY POLICY SPECIFICALLY IN SECTION 13.02.038 "WAIVER OF CHARGES; ADJUSTMENTS TO BILL" INCORPORATING A LEAK ADJUSTMENT POLICY.

This policy was discussed and passed under Item #8 allowing for leak adjustments using 12 months to calculate the adjustment and this policy goes with the address not the owner.

12. CONSIDER APPROVAL OF RESOLUTION #1029-2020 AMENDING ARTICLE V "LEAVE POLICIES" (d) "HOLIDAYS DESIGNATED" OF THE EMPLOYEE PERSONNEL POLICY BY ADDING PRESIDENTS DAY AND VETERANS DAY AS OFFICIAL PAID HOLIDAYS FOR THE CITY.

Eleven other cities paid holidays were presented. Staff is requesting Presidents Day and Veterans Day as city paid holidays which would start in 2021.

Mayor Pro Tem Ashton moved, seconded by CM Claridge to approve the two additional holidays as presented. Mayor Pro Tem Ashton, CM Claridge and CM Houk voted "Aye". CM Holland and CM Chisholm voted "Nay". Motion passed.
