AS REQUESTED BY JOLLY DREAMS CORPORATION FOR THE SALE OF ALCOHOLIC BEVERAGES (BEER & WINE) IN ACCORDANCE TO SECTION 23A.G.3.J FOR OFF-PREMISE CONSUMPTION (CONVENIENCE STORE) PURSUANT TO ZONING ORDINANCE #1286-2020 AS ADOPTED AND AS AMENDED. (ZONING CASE #SUP 2020-0006)

At 7:05 p.m., Mayor Ashton opened the Public Hearing.

Jolly Walia was present. This went before the Planning and Zoning Commission with one opposition and the board approved the request five to zero. The current building on this lot will be demolished and a 2,500 square foot convenience store will be built. This meets the TACB requirements. There is a 20-foot public right of way that is still under discussion. Mr.

Walia has not closed on the property yet but is pretty sure it will be soon. This convenience store will have a kitchen in it and have a drive thru window. This store will be a large store and very well lite. Unsure of hours of operations at this point. The restrooms will be all touchless. The name of the convenience store will be Jolly's. There will be a screening fence against the residential properties. Carl that resides across the street at 1309 Long Avenue was present has no objections to the alcohol but had several concerns and questions. Tonight, the only item that is on this agenda is for the approval of alcohol beverages. The site plan will be discussed at another time. It was recommended that Carl meet with Mr. Walia to discuss issues. Mr. Walia will demolish the building now and has 120% certainty that he will close on this property and move forward with a building. Hopes to have the building completed within six months.

At 7:33 p.m., Mayor Ashton closed the Public Hearing.

(ZONING CASE #SUP 2020-0006)

Mayor Pro Tem Houk moved, seconded by CM Claridge to approve the Specific Use Permit at 4710 River Oaks Blvd. as requested for by Jolly Dreams Corporation for the sale of alcoholic beverages (beer & wine) in accordance to Section 23A.G.3.j for off-premise consumption pursuant to Zoning Ordinance #1286-2020 as adopted and as amended providing that the following stipulations are complied with: 1) Contingent on obtaining site plan approval pursuant to Section 25 of the River Oaks Zoning Ordinance; and 2) Contingent on completing the construction of the convenience store in accordance to the 2015 International Building Code as adopted and as amended and final approval of a commercial certificate of occupancy in order to open the business; and 3) must meet all TABC permitting requirements for Alcoholic Beverage Sales (Beer & Wine). All voted "Aye".

Permit Tech Melanie McNary-Whitley researched other cities permit fees that are similar in our population. Siding, drive approaches, flat work, fences, etc. brought in outrageous permit fees and we came up with more reasonable costs. Hot tubs and saunas were added in. The changes that were done are highlighted in red. It was brought up about changing the sign ordinance which a workshop will be held soon, and changes will be brought back to council for approval. This ordinance change tonight will not change the sign fees. A resident pulled

a permit for siding and the fee was outrageous and had to investigate changing the permit fees quickly.

# CM Holland moved, seconded by CM Chisholm to approve Ordinance #1298-2020. All voted "Aye".

There is a new director at the YMCA and her preference is for the animal shelter to go on Harvard. We can continue to stay at the Alamo Building, but we need to be actively looking for a permanent location. The short-term location is the Tulane location and the long-term location is the Meandering location. A participation agreement will be drawn up when time comes.
