1. CALL TO ORDER

With a quorum present, Mayor Earwood called the Special Meeting of the River Oaks City Council to order at 12:00 noon on Monday, March 23, 2020 at the River Oaks Event Center, 5300 Blackstone Drive, River Oaks, Texas 76114.

2. INVOCATION

Mayor Pro Tem Ashton delivered the Invocation.

PLEDGE OF ALLEGIANCE TO UNITED STATES FLAG AND THE TEXAS FLAG

Mayor Pro Tem Ashton led the Pledges of Allegiance to the United States and the Texas Flags.

Mayor Earwood announced that this budget this year, the city financially will be fine. But at budget time next year, we will be seeing a financial impact. Reserve accounts are frozen and there will be only necessity purchases. Thinks it could take a minimum of three years to recover financially.

City Attorney Anderlee-government suspended Public Testimony; therefore it is not required. Requirements are still required and we will have to make it available for the public to call in if meetings are held.

Mayor Earwood-adopted everything that Tarrant County has adopted. We will follow the law.

CM Houk-recommends having a Resolution that we will follow Tarrant County instead of doing a separate Resolution for each change. Does not mind video conferencing or phone conferencing in order to have meetings.

Mayor Pro Tem Ashton-urges everyone to watch the Tarrant County Commissioners Court tomorrow to see how they are doing things. A lot of statutes are suspended but there are things we have to meet to be in compliance.

CM Gregory-right now a quorum is not necessary and is working on allowing the public to call in if they need to. There were two complaints submitted by email: 1) need to push absentee voting, and oppose of not having a quorum, wants three council to vote on items. 2) giving an unelected employee control is not acceptable.

8. CONSIDER APPROVAL OF RESOLUTION #1012-2020 UNDER THE AUTHORITY OF THE GOVERNOR TO THE EXTENT NECESSARY TO ALLOW POLITICAL SUBDIVISIONS THAT WOULD OTHERWISE HOLD ELECTIONS ON MAY 2, 2020, TO MOVE THEIR GENERAL AND SPECIAL ELECTIONS FOR 2020 ONLY TO THE NEXT UNIFORM ELECTION DATE, OCCURRING ON NOVEMBER 3, 2020, WITHOUT OTHERWISE ADJUSTING THE TERM OF OFFICE.

Castleberry Independent School District voted this morning to postpone their election to November 3, 2020. The Tarrant County Election Administrator is very concerned because they probably will not be able to get employees to work the polls if held on May 2, 2020. If we decide to hold the election in May, it will have to be moved to the Event Center in order to provide social distancing. The Tarrant County Judge recommended postponing the May elections but the City Councils have to approve it. Some cities would like to get a proclamation

going to hold a July election. If we continue with the May election, the total cost of the election would be the city's responsibility. This virus is closer to the beginning than the end. The general population does not have discipline to follow the rules. If the May election continues, the candidates will be restricted on being able to go door to door and making personal contact.

Mayor Pro Tem Ashton moved, seconded by CM Chisholm to approve Resolution #1012-2020 and have staff pursue all opportunities to hold the election earlier if permitted. All voted "Aye".

9. CONSIDER APPROVAL OF RESOLUTION #1013-2020 CONSENTING AND EXTENDING THE DECLARATION OF LOCAL DISASTER AND ORDER OF THE MAYOR; IMPOSING A PENALTY FOR VIOLATION THEREOF.

The Mayor issued the first and second amendment which is the same as Tarrant County. This Resolution extends the disaster until May 2020. Texas Municipal League suggested each city do a separate Declaration. In order to receive funding, a local Declaration is required. The city's Declaration does not override Tarrant County's. We can lessen the time if things improve.

CM Claridge moved, seconded by CM Chisholm to approve Resolution #1013-2020 for an additional 90 days from today. All voted "Aye".

This gives the City Manager under an emergency disaster to continue functioning on if the council cannot hold a meeting. This can be amended at any time. This only will go into action when a State disaster is declared.

CM Holland moved, seconded by Mayor Pro Tem Ashton to approve Resolution #1014-2020. CM Holland, CM Chisholm, CM Houk and Mayor Pro Tem Ashton voted "Aye". CM Claridge voted "Nay". Motion passed.
