7. CONSIDER APPROVAL OF ORDINANCE #1276-2020 CONSENTING AND EXTENDING THE THIRD AMENDMENT DECLARATION OF LOCAL DISASTER AND ORDER OF THE MAYOR; IMPOSING A PENALTY FOR VIOLATION THEREOF.

The Tarrant County Executive Order is thru April 7, 2020. River Oaks has closed the parks and recreational areas and the City Hall lobby is closed to the public. Today the Governor ordered churches as essential and can have service if they cannot televise it over social media or by other means. But they have to comply with the social distancing rule. River Oaks can extend their order thru the end of April.

Mayor Pro Tem Ashton moved, seconded by CM Claridge to approve Ordinance #1276-2020 consenting and extending the third amendment declaration of local disaster and order of the Mayor imposing a penalty for violation thereof with the provision that it will extend thru April 30, 2020 as the President's current guild lines do and that if anything is in conflict with the county or the state with the understating that there may be parts that are not necessarily enforceable right now but they will be enforceable as the higher authorities will allow. All voted "Aye".
