8. CITIZEN APPEARANCE OF GUADALUPE LOYOLA REQUESTING EXCEPTION TO SECTION 13.04.013 "SEWER SERVICE RATES" SETTING THE WINTER QUARTERLY AVERAGE FOR SEWER RATES.

Guadalupe Loyola was not present. Ms. Loyola has not lived there the full three months. Because she is new to the city, she gets city wide averaging. Said according to her past usage when she lived in Fort Worth, she did not use that much water and would like an exception. If the city passes this exception, other new customers will want the same exception.

CM Chisholm moved, seconded by CM Rodriguez to deny the request of Guadalupe Loyola. All voted "Aye".

9. DISCUSSION AND/OR ACTION TO ADOPT RESOLUTION #1044-2021 CONTINUING, AMENDING, RESCINDING OR SUPERSEDING PREVIOUS LOCAL DISASTER ORDERS REGARDING MASK MANDATES AS RESCINDED BY THE GOVERNOR OF THE CITY'S HEALTH AND SAFETY POLICY REGARDING MASK MANDATES.

Tarrant County Commissioners Court decided today to keep the mask and social distancing policy in county offices as is. The Governor made a ruling on individuals, but the county made a ruling on businesses. All we can do is make the decision for the city owned properties. It is recommended to keep the mask and social distancing policy in place on all city buildings. No

10. CONSIDER APPROVAL OF ECONOMIC DEVELOPMENT PERFORMANCE AGREEMENT WITH 2D PARTNERS L.P. AT 2621 JACKSBORO HIGHWAY AS RECOMMENDED BY THE ECONOMIC DEVELOPMENT CORPORATION ON FEBRUARY 8, 2021.

A red-line version was sent out to the council that was revised by the City Attorney. This does not require two readings, but the City Council does have to approve this. This is to help with permit fees and infrastructure.

CM Holland moved, seconded by CM Claridge to approve the agreement with 2D Partners subject to the City Attorney adding the base value. All voted "Aye".

11. CONSIDER APPROVAL OF RESOLUTION #1047-2021 AUTHORIZING ECONOMIC DEVELOPMENT CORPORATION (EDC) EXPENDITURES FROM THE 2020-2021 FISCAL YEAR BUDGET AS QUALIFIED FOR A PROJECT MORE THAN \$10,000.00 FOR PERFORMANCE DEVELOPMENT AGREEMENT WITH CARLETON PROPERTIES, LTD %COLLIER ALBRIGHT AT 5300 RIVER OAKS BLVD. (FIRST READING)

Collier Albright was present. EDC approved the Development Agreement last night. This is for the opening of Grumps Burgers at the old Chicken Express building. Currently there are locations in Burleson, Cleburne, Granbury, Stephenville and Abilene. The next step is applying for a Specific Use Permit. This agreement is for parking lot improvements. Are in the process of purchasing the green space from Taco Bell for a parking lot. The agreement will start October 1, 2021.

CM Chisholm moved, seconded by CM Claridge to approve Resolution #1047-2021. All voted "Aye".

CONSIDER APPROVAL OF ORDINANCE #1305-2021 TRANSFERRING FUNDS FROM THE FY 2020-2021 GENERAL FUND PRIOR YEAR FUNDING TO FY 2020-2021 WATER FUND BUDGET DUE TO UNPLANNED EMERGENCY EXPENDITURES INVOLVING LABOR, WATER PURCHASES, EQUIPMENT AND REPAIR COSTS DUE TO THE RECENT WATER OUTAGE DURING THE WINTER STORM.

Applying for FEMA reimbursement is a long process. We have estimated \$246,000.00 in water purchases, overtime, and repairs. The City Auditor agrees that the best way to handle this is to transfer these funds from the General Fund over to Water Sewer until the FEMA reimbursement comes in.

CM Claridge moved, seconded by CM Rodriguez to approve Ordinance #1305-2021. All voted "Aye".

13. CONSIDER APPROVAL OF RESOLUTION #1045-2021 AUTHORIZING CONTINUED PARTICIPATION WITH THE STEERING COMMITTEE OF CITIES SERVED BY ONCOR; AND AUTHORIZING THE PAYMENT OF SIX CENTS PER CAPITA TO THE STEERING COMMITTEE TO FUND REGULATORY AND LEGAL PROCEEDINGS AND ACTIVITIES RELATED TO ONCOR ELECTRIC DELIVERY COMPANY, LLC.

This is approved every year.

CM Chisholm moved, seconded by CM Claridge to approve Resolution #1045-2021. All voted "Aye".

14. CONSIDER APPROVAL OF RESOLUTION #1046-2021 FOR OUTSIDE SPECIAL EVENT PERMITTING AS REQUESTED BY YOLIE RODRIGUEZ REQUESTING PERMISSION TO HOLD A POP-UP EVENT OUTSIDE AT THE RIVER OAKS EVENT CENTER.

This item is not needed.

15. CONSIDER APPROVAL OF ORDINANCE #1306-2021 AMENDING THE FY 2020-2021 GENERAL FUND BUDGET FOR THE EXPENDITURE OF PARK DOLLAR DONATIONS FOR PARK IMPROVEMENTS AT MCGEE PARK.

Park Board approved the expenditure of \$4,545.00 from \$1 donations to Allied Fence for a 58' wide x 12' high chain link fence by the basketball goals at McGee Park to keep the balls inside.

CM Claridge moved, seconded by CM Chisholm to approve Ordinance #1306-2021. All voted "Aye".

American Tower has agreed to raise the monthly rent to \$1,697/month for a 35-year lease term and convert your escalator from every five years to every year. The City will receive 25% gross rents from any new carriers that American Tower manages to install into the tower/premises after the date the amendment is effective. American Tower will remain responsible for all maintenance to its tower, equipment and equipment shelter but will not be responsible for the maintenance of any radio equipment on the tower that belongs to the City. A relocation provision will be added to the lease amendment. American Tower will be asked to draft the lease amendment.
