(ZONING CASE #PZ 2021-0004 RZ).

At 7:05 p.m., Mayor Ashton opened the Public Hearing.

Juanita Nunez is present. Ms. Nunez came in for a re-plat and it was determined this lot is zoned Planned Development. There is only one residential house on this lot. The request is to change the zoning to R-3 Single Family. The Planning and Zoning Commission voted 5 to 0 to approve the request. There was no opposition. This will make the lot with the house about an acre and the other lot about two acres.

At 7:07 p.m., Mayor Ashton closed the Public Hearing.

10. ACTION FROM PUBLIC HEARING: CONSIDER APPROVAL OF ORDINANCE #1307-2021 REZONING BLOCK 4, LOT 23R IN THE ROCKWOOD TERRACE ADDITION OTHERWISE KNOWN AS 1813 LONG AVENUE IN RIVER OAKS, TARRANT COUNTY, TEXAS AS REQUESTED BY JUANITA NUNEZ FROM A "PD" PLANNED DEVELOPMENT ZONING DISTRICT TO A "R-3" SINGLE-FAMILY ZONING DISTRICT PURSUANT TO SECTION 10 OF THE RIVER OAKS ZONING ORDINANCE #1286-2020 AS AMENDED. (ZONING CASE #PZ 2021-0004 RZ).

CM Claridge moved, seconded by Mayor Pro Tem Houk to approve Ordinance #1307-2021. All voted "Aye".

11. PUBLIC HEARING: IN ORDER TO RECEIVE CITIZEN COMMENTS ON THE PROPOSED APPLICATION SUBMITTED BY JUANITA NUNEZ ON THE PROPOSED REPLAT APPLICATION IN ORDER TO SUBDIVIDE 2.8920 ACRES OF LAND IN THE ROCKWOOD TERRACE ADDITION AND ONCE SUBDIVIDED TO BECOME TWO SEPARATELY PLATTED "R-3" SINGLE FAMILY RESIDENTIAL LOTS. (ZONING CASE #PZ2021-0005).

At 7:09 p.m., Mayor Ashton opened the Public Hearing.

Juanita Nunez is present. The existing lot with the house will be Lot 23R2. The existing house was built in 2005 before the Flood Insurance Rate Map was revised. The only corrections needed in the re-plat is that the building setbacks are 30-feet not 40-feet and side setbacks would be 5-feet to meet the R-3 requirements.

The vacant lot will be Lot 23R1. The lot will be 276.01 feet long and its narrowest point by 250 feet wide along the street and will meet the R-3 requirements for the front, side, and rear yard setbacks. According to the Flood Insurance Rate Map, a portion of the newly subdivided lot is in the Zone X flood area that is a 2% annual chance of floods, and an area of 1% annual chance of floods with average depths of less than 1-foot or with drainage areas less than 1 square mile. According to the re-plat there is an area designated on the re-plat on both sides of the creek across the property that is zoned "AE" as of March 31, 2019 that is in the zone where base flood elevations have been determined. The floodways will impact when building a new residential structure requiring having to obtain a special flood plain permit and must be engineered designed to build but does not impact the property itself from being re-platted. The only corrections needed to the re-plat is that the front building setbacks are 30-feet not 40-feet and side setbacks would be 5-feet to meet the R-3 requirements. The Planning and Zoning Commission voted 5 to 0 to approve the request.

At 7:16 p.m., Mayor Ashton closed the Public Hearing.

12. ACTION FROM PUBLIC HEARING: CONSIDER APPROVAL OF THE APPLICATION SUBMITTED BY JUANITA NUNEZ IN ORDER TO SUBDIVIDE 2.8920 ACRES OF LAND IN THE ROCKWOOD TERRACE ADDITION AND ONCE SUBDIVIDED TO BECOME TWO SEPARATELY PLATTED "R-3" SINGLE-FAMILY RESIDENTIAL LOTS. (ZONING CASE #PZ2021-0005).

CM Holland moved, seconded by Mayor Pro Tem Houk to approve the re-plat request with the Planning and Zoning Commission corrections. All voted "Aye".

There were a few areas that budget amendments were needed in General Fund: Equipment Upgrades in the amount of \$32,000.00 to cover the over budgeted amount and the desktop police computers that need to be replaced; Computer Support Maintenance in the amount of \$9,500.35 to cover additional costs; Park Small Equipment Repairs in the amount of \$4,000.00 to replace the hydraulic pump on the ball field groomer.

In the Water Sewer Fund: requested is a budget transfer of \$15,000.00 from the Sewer Department to the Water Distribution Department to cover account shortfalls.

CM Claridge moved, seconded by Mayor Pro Tem Houk to approve Ordinance #1308-2021. All voted "Aye".

14. CONSIDER APPROVAL OF ORDINANCE #1308-2021 AMENDING CHAPTER 3 "BUILDING REGULATIONS" ARTICLE 3.12 "SIGNS" IN SECTION 3.12.135 "POLITICAL SIGNS" SPECIFICALLY IN SUBSECTION (c)(1) ESTABLISHING THE REASONABLE REGULATION OF ELECTIONEERING ON PUBLIC PROPERTY USED AS A POLLING PLACE, BY RELOCATING THE ELECTIONEERING ZONE THAT WAS PROVIDED FOR AS EXHIBIT A TO ORDINANCE #1022-2014 THAT IS NOW LOCATED WITHIN 100-FEET OF THE POLLING PLACE IN VIOLATION OF THE ELECTION CODE AND SHALL BE RELOCATED.

Since the polling site has changed from City Hall to the Annex Building, the electioneering zone needs to be relocated. There is now a space marked off on the west side of the Annex Building that is marked off for the electioneering zone and the zone also includes four parking spaces on the other side of the bus stop in front of the Police Department. The median in front of City Hall is full of political signs (none of which are CISD and City Council candidates). That area is owed by TXDOT therefore the signs are placed there illegally. Our City Attorney advised us not to move the signs but to contact TXDOT for them to move them if they choose to.

Mayor Pro Tem Houk moved, seconded by CM Claridge to approve Ordinance #1308-2021. All voted "aye".

15. CONSIDER APPROVAL OF ORDINANCE #1310-2021 AMENDING ARTICLE A.02 "SCHEDULE OF FEES AND CHARGES"; SPECIFICALLY IN SECTION A.02.002 "REGISTRATION OF CONTRACTORS GENERALLY" SPECIFICALLY IN (6) "ROOFING CONTRACTORS" BY REVISING THE REQUIREMENTS OF ROOFING CONTRACTORS EXEMPTING THEM FROM PERMITTING AND INSPECTION PROCEDURES FOR RE-ROOFING EXCEPT WHEN INVOLVING CERTAIN STRUCTURAL REPAIRS.

There seems to be a misunderstanding with staff as to permitting for registered roofing contractors. The Ordinance states even though a roofing contractor has paid for their annual registration, they will have to pull a permit at no cost. Non-registered roofers will have to pull and pay for permits for each job plus get city inspections on the properties. If there is 25% of roof decking being replaced, regardless a permit must be pulled because it is considered structural. CM Gregory recommends to not do roofing inspections since there is not much to inspect.

No action taken. Will bring back to not to require roofing permits and/or inspections.

16. DISCUSSION AND/OR ACTION ON ADOPTING RESOLUTION #1044-2021 FOR THE CONTINUATION, MODIFICATION OR REVISION OF LOCAL DISASTER AND ORDER OF THE MAYOR OF THE CITY OF RIVER OAKS REGARDING THE CORONAVIRUS PANDEMIC.

Tarrant County has not changed their mask mandate order. If the mask mandate is removed on city buildings, the disaster order will remain in effect for funding purposes.

Mayor Pro Tem Houk moved, seconded by CM Claridge to remove the mask mandate in city buildings but to recommend the wearing of masks which is optional. All voted "Aye".

CM Rodriguez excused herself from this item and abstained from voting. Lonnie was present to speak regarding this item. Pop-up events have free samples of alcoholic beverages. They do follow TACB rules. Restaurants can come and vendors can come who sell machines to hand out samples. The samples are limited, and they will card the person requesting the sample. Council agreed since this is samples and not considered drinking, an officer will not have to be present.

Mayor Pro Tem Houk moved, seconded by CM Claridge to approve handing out free samples of alcoholic beverages at the pop-up events at the Event Center. All voted "Aye".
