8. PUBLIC HEARING CONTINUED: IN ORDER TO RECEIVE PUBLIC INPUT ON SUBSTANDARD BUILDING ENFORCEMENT ACTION REGARDING STRUCTURE(S) LOCATED ON THE PROPERTY AT 1017 CHURCHILL ROAD.

No one was present. At 7:09 p.m., Mayor Earwood closed the Public Hearing.

9. ACTION FROM PUBLIC HEARING: CONSIDER COUNCIL ORDERS ON THE PROPERTY AT 1017 CHURCHILL ROAD THAT MAY INCLUDE SECURING, VACATING OF OCCUPANTS, REMOVAL, REPAIRING OR DEMOLITION OF STRUCTURE(S) OR ADOPTION OF RESOLUTION IMPLORING A FEDERAL AGENCY TO ABATE ALL SUBSTANDARD VIOLATIONS IN ORDER TO BE BROUGHT INTO COMPLIANCE WITH SECTION 3.07.004 OF THE RIVER OAKS CODE OF ORDINANCES (2006) AS AMENDED.

BI Sanders-there is a new owner whom presented a plan of action.

Mayor Pro Tem Ashton moved, seconded by CM Claridge to find that the building located at 1017 Churchill Road based on evidence presented at this hearing; is

Substandard and: 1) that the conditions set forth in the Building Official's report exist to the extent that the life, health, property, or safety of the public (and occupants of the building(s), if applicable) are endangered; and 2) that the building(s) is/are feasible of repair and therefore order the building to be repaired by the owner within 89 days and the lienholder or mortgagee to within an additional 30-days if the owner does not comply; and 3) the board orders commencement of the repairs within 30-days and has established specific time schedules with the owner or mortgagee for the repair; and 4) order that the building be repaired in conformance with the requirements of Section 3.07.004 of the River Oaks Code of Ordinances (2006) as amended or demolished by the owner and the debris removed within 89 days or by the lienholder and mortgagee to within an additional 30-days if the owner does not comply and further find that if the building is not repaired within 89 days, that there is no reasonable probability that the building will be repaired within a reasonable period of time if additional time is given. If the building is not repaired within 89 days in full conformance with Section 3.07.004 of the River Oaks Code of Ordinances (2006), the building shall be demolished. 5) order that the substandard fee of \$150.00 be paid upon permit issuance. Certificate of Occupancy will not be finaled until all substandard fees are paid in full. All voted "Aye".

There is some funding assistance available but right now there isn't any information to inform Council on. There is an estimate loss of revenues of about \$50,000 due to late charges being waived and credit card fees being waived. The resident's water bills are not waived. Hopefully, we will have more information at the May 12, 2020 council meeting about funding assistance.

11. DISCUSSION AND/OR ACTION REGARDING EMPLOYEE LEAVE AND PAY OPTIONS RELATED TO THE COVD-19 PANDEMIC AS IMPLEMENTED BY THE CITY MANAGER UNDER THE PLAN FOR CONTINUATION OF FUNCTIONS IN THE EVENT OF A DISASTER.

We are following the plan Tarrant County is using on hazardous pay. As of 11:59 p.m. tonight, the hazardous pay ends; and the negative sick time will be discontinued.

12. CONSIDER APPROVAL TO PURCHASE 0.148 ACRES OF LAND IN THE A. VAN NORDSTRAND SURVEY FROM THE CITY OF FORT WORTH FOR THE TOTAL PURCHASE PRICE OF \$1,600.00.

EDC has been working with the City of Fort Worth for a while now so we can put an entrance sign on this piece of land.

CM Chisholm moved, seconded by Mayor Pro Tem Ashton to approve the purchase of 0.148 acres of land from the City of Fort Worth for the purchase price of \$1,600.00.

13. DISCUSSION AND/OR ACTION REGARDING THE REMAINING FUNDING BALANCE ALLOCATED BY THE TEXAS WATER DEVELOPMENT BOARD TO BE EXPENDED AS PHASE 3 UNDER THE CLEAN WATER STATE REVOLVING FUND AS PRESENTED BY PWD GORDON SMITH.

The remaining construction budget after Phase 2 sewer project will be \$379,938.89. Staff is recommending a Phase 3 project in the amount of \$250,000.00 which will include Springer, a section of Black Oak and section of Almena.

Due to costs Woodlawn, Yale and Black Oak were selected to remain in the current street improvement budget. The City Manager has asked for a possible solution and cost estimate for a smoother road on Roberts Cut Off from River Oaks Blvd to Blackstone. An option for now is to wait until the new budget workshops and do patching for now. Suggestion would be to go out for bids and we do not have to accept the bids. Council agreed to get new costs and bring back.

There was a grading issue on Byrd Drive; therefore, increasing the city pledge amount an additional \$10,000.00.
