With a quorum present, Mayor Herman Earwood called the Regular Meeting of the River Oaks City Council to order at 7:00 p.m. on Tuesday, May 14, 2019 at the River Oaks City Hall, 4900 River Oaks Blvd., River Oaks, Texas 76114.

CM Ashton moved, seconded by CM Houk to approve the Consent Agenda Items #A-E and #G-H with removal of Item #F for discussion. All voted "Aye".

Mayor Earwood introduced Anna Lee as the new Library Director.

6. DISCUSSION OR ACTION TAKEN ON ITEMS WITHDRAWN FROM CONSENT AGENDA FOR SEPARATE DELIBERATION.

Item #F-the Fire Department ran a gas call in which they smelled gas. The gas detector did not read. Had the company come out and confirmed it did not work and cannot be serviced. A week later received another gas call but had no working detector. The best option is a lease agreement for \$581 a month for three years with periodical testing on the detector. Had an agreement years ago but with the Fire Chief personnel changes, the agreement did not get renewed.

CM Ashton moved, seconded by CM Butler to approve the agreement with SRS for gas sensor equipment for three years. All voted "Aye".

PERSONAL APPEARANCES AND ITEMS REQUIRING COUNCIL APPROVAL/ACTION:

7. CONSIDER APPROVAL TO AMEND THE APRIL 9, 2019 BOARD ORDER ON SUBSTANDARD PROPERTY AT 928 LYDICK LANE AS REQUESTED BY THE NEW PROPERTY OWNER, SAMUEL CERVANTEZ.

Samuel Cervantez was present. In the process of determining what work needs to be done. Previous owner is still in the process of packing and moving her items out. Is requesting 60 days or less to bring back to Council a plan of action. City staff at this point will not be responsible for un-boarding and re-boarding the house up for the previous owner. BI Sanders requests that the dumpster be tarped.

CM Ashton moved, seconded by CM Chisholm to amend the April 9, 2019 board up order: to extend the substandard order for 60 days, to remove the current board up order, and to appear back within 60 days from today with a plan of action. The substandard order will remain in place. All voted "Aye".

8. CONSIDER APPROVAL OF CONTRACT WITH TARRANT COUNTY TAX OFFICE FOR ASSESSMENT AND COLLECTION OF AD VALOREM TAXES FOR YEARS 2019-2021.

The only difference is from last year is that the cost is .98 cents per account and this is a three year agreement.

CM Ashton moved, seconded by CM Chisholm to approve the three year contract with Tarrant County Tax Office. All voted "Aye".

9. CONSIDER APPROVAL OF RESOLUTION #965-2019 CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE SPECIAL MEASURES & GENERAL ELECTION HELD ON MAY 4, 2019 IN THE CITY OF RIVER OAKS, TEXAS; AND PROVIDING AN EFFECTIVE DATE.

The official results are:

Council Place 1: Karen Wright-38 votes, 9.87%; JoAnn Butler-182 votes, 47.27%; John Claridge-165 votes, 42.88%.

Council Place 3: Sherrie Uptmore Dast-154 votes, 39.19%; Darren Houk-240 votes, 60.91%.

Proposition A: Yes-254 votes, 66.15%; No-130 votes, 33.85%.

Proposition B: Yes-216 votes, 56.54%; No-166 votes, 43.46%.

Proposition C: Yes-253 votes, 66.75%; No-126 votes, 33.25%.

Proposition D: Yes-232 votes, 60.73%; No-150 votes, 39.27%.

There were a total of 397 ballots cast. Council Place 1 will be in a runoff election.

Mayor Pro Tem Holland moved, seconded by CM Butler to approve Resolution #965-2019. All voted "Aye".

10. CONSIDER APPROVAL OF RESOLUTION #966-2019 CALLING FOR A RUNOFF ELECTION TO BE HELD ON JUNE 8, 2019 FOR PLACE 1 CITY COUNCIL MEMBER; APPROVING A JOINT ELECTION WITH TARRANT COUNTY; AND ESTABLISHING PROCEDURES FOR THAT ELECTION; AND PROVIDING AN EFFECTIVE DATE.

Early voting will be May 28-June 4, 2019 at City Hall. Election day is June 8, 2019 at City Hall.

CM Ashton moved, seconded by CM Chisholm to approve Resolution #966-2019. All voted "Aye".

11. CONSIDER APPROVAL OF RESOLUTION #967-2019 FOR SPECIAL EVENT PERMITTING TO HOLD THE ALL AMERICAN FESTIVAL ON JUNE 29, 2019.

This year's festival is a joint cooperation with Victory Church who donated \$2,500 towards the fireworks. Victory Church will be holding an event. All the city is in charge of is the fireworks.

CM Chisholm moved, seconded by CM Ashton to approve Resolution #967-2019. All voted "Aye".
