8. CONSIDER APPROVAL OF RESOLUTION #1055-2021 CANVASSING ELECTION RETURNS AND DECLARING THE RESULTS OF THE RUN-OFF ELECTION HELD ON JUNE 5, 2021 FOR THE PURPOSE OF ELECTING A CITY COUNCIL PLACE 4 MEMBER.

Early Voting: Yolie Rodriguez 167 votes, 61.17% (2 absentee (50%), 96 early (62.75%), and 69 voting day (59.48%). Sherrie Uptmore Dast 106 votes, 38.83% (2 absentee (50%), 57 early (37.25%), and 47 election day (40.52%). There were two under votes that did not count.

CM Chisholm moved, seconded by Mayor Pro Tem Houk to approve Resolution #1055-2021 declaring Yolie Rodriguez as Place 4 City Council Member. All voted "Aye".

Mayor Ashton presented the Certificate of Election to Council Member Place 4 Yolie Rodriguez. CM Gregory gave the Statement of Election/Appointed Officials and Oath of Office to Council Member Place 4 Yolie Rodriguez.

PERSONAL APPEARANCES AND/OR ITEMS REQUIRING COUNCIL APPROVAL/ACTION:

CONSIDER ELECTION OF MAYOR PRO-TEMPORE FOR THE 2021-2022 TERM YEAR.

CM Claridge moved, seconded by CM Rodriguez to re-elect Darren Houk as Mayor Pro Tem. CM Claridge, CM Rodriguez, CM Chisholm and Mayor Pro Tem Houk voted "Aye". CM Holland voted "Nay". Motion passed.

CM Holland noted that this was discussed the last time a Mayor Pro Tem was elected and feels since it has been the practice in the past to rotate this position to the senior Council Member and

right now it is CM Chisholm's turn to be Mayor Pro Tem. CM Chisholm appreciates this, but we are all part of a team and is comfortable with this decision.

11. DISCUSSION AND/OR ACTION ON APPROVING THE JOINT ORDINANCE AND BOUNDARY AGREEMENT AS RIVER OAKS ORDINANCE #1314-2021 ADJUSTING THE BOUNDARIES BETWEEN CITY OF FORT WORTH AND CITY OF RIVER OAKS ON 5.892 ACRES OF LAND THAT ACCORDING TO T.A.D. RECORDS IS DESCRIBED AS BEING BLOCK 1, LOT 3A, BLOCK 1, LOTS 3A & 3A1 IN THE WHITE SETTLEMENT HEIGHTS ADDITION OTHERWISE KNOWN AS 4800 WHITE SETTLEMENT ROAD LOCATED CURRENTLY IN THE FORT WORTH CITY LIMITS.

The only thing remaining is the property description. The drafted ordinance matches up with what the Tarrant Appraisal District has as the property description. Approving this boundary adjustment helps with emergency response so River Oaks personnel will respond to the whole high school. It states in this agreement that the City of Fort Worth will continue to provide water and wastewater services. If the school does any building improvements on the property, the permits will be thru the City of River Oaks. If there are drainage issues, there is language in the agreement stating it is the school district's problem.

CM Chisholm moved, seconded by Mayor Pro Tem Houk to approve Ordinance #1314-2021 with the noted map controls. All voted "Aye".

Mayor Ashton mentioned this is a 90-day moratorium for the uses of:

- a) cigar or tobacco stores, Section 14(B)(8), Vape Shops
- b) massage establishments, Section 14(B)(32)
- c) public garages for repair of automobiles, Section 15(B)(14) body and tire repair shops
- d) tattoo studios, Section 15(B)(33) and body piercing
- e) pawn shops, Section 16(B)(6)
- f) title loans, predatory loans, and cash checking places
- g) standalone outside money dispensing kiosks
- h) laundromats

CM Claridge counted 14 noticeable auto repair shops in River Oaks. Planning and Zoning added laundromats and standalone outside money dispensing kiosks.

CM Chisholm moved, seconded by Mayor Pro Tem Houk to approve Ordinance #1313-2021 a 90-day moratorium for items #A-H. All voted "Aye".
