8. CONSIDER APPROVAL OF ORDINANCE #1289-2020 APPROVING REINVESTMENT ZONE NO. 1, CITY OF RIVER OAKS, FINAL PROJECT AND FINANCE PLAN.

Trent Petty & Kirk McDaniel with Petty and Associates were present.

Met with the board earlier and they approved the bylaws and recommended to the City Council Zone #1, the final project and the finance plan. Also presented was the map that squares the zone off.

CM Chisholm moved, seconded by CM Holland to approve Ordinance #1289-2020. All voted "Aye".

9. CONSIDER APPROVAL OF RESOLUTION #1024-2020 AMENDING RESOLUTION #1021-2020 AS ADOPTED ON JULY 14, 2020 BY CONTINUING THE DECLARATION OF LOCAL DISASTER.

A declaration was signed to close the Event Center and to continue the closure of the Library. This declaration expires August 14, 2020. This new order will remain in effect until it is rescinded. We are still in considerable danger and at the Event Center, it is hard to enforce the masks and people do not wear them properly and the cleaning is an issue. The elderly are the ones passing away from the virus or by complications from the virus. And the elderly are the ones that are the most at the center. Event Center Director Wheat felt it is no one's business on how she keeps herself safe. There are different rules at different places. People are coming to the food bank not to get food, but to talk to someone. Since the closure, repairs are being done at the center that could not be done when the center is open.

CM Chisholm moved, seconded by CM Holland to approve Resolution #1024-2020. All voted "Aye".

10. CONSIDER APPROVAL OF INTERLOCAL TERMINAL/NON-TERMINAL AGENCY AGREEMENT BETWEEN CASTLEBERRY INDEPENDENT SCHOOL DISTRICT POLICE DEPARTMENT AND RIVER OAKS POLICE DEPARTMENT.

This was discussed about a year ago and we are to receive \$25,000 annually. All attorneys are fine with the plan. PC Spieldenner would like the removal of Article 4 which states River Oaks would provide them space for evidence.

CM Holland moved, seconded by CM Houk to approve the Interlocal Agreement with CISD Police Department with the removal of Article 4. All voted "Aye".

11. CONSIDER APPROVAL OF REQUEST FROM METROPOLITAN EMS AUTHORITY (MAEMSA) FOR THE CITY TO PAY MAEMSA FROM CARES ACT FUNDING RECEIVED FROM TARRANT COUNTY IN ORDER TO OFFSET UNBUDGETED PANDEMIC-RELATED COSTS INCURRED BY MAEMSA.

Medstar group reached out to the member cities and asked for an even portion from each city. The request is for \$2,354.19. Medstar experienced a reduction in ambulance service because of the COVID-19 and are preparing thru their fee schedule in their budget for the upcoming years. Right now, River Oaks has a very small reserve remaining in the Cares Act.

Mayor Pro Tem Ashton moved, seconded by CM Houk to deny the request from MAEMSA. All voted "Aye".

12. CONSIDER APPROVAL OF CONTRACT WITH TARRANT COUNTY FIRE ALARM CENTER FOR FIRE DEPARTMENT DISPATCH SERVICES IN FY 2021.

The cost is a 3% increase which is \$32,604 for the annual renewal. Saginaw and Lake Worth have switched to Fort Worth Fire Dispatch. We are exploring switching over to Fort Worth which would increase efficiency. We have been in contact with the Fort Worth Fire Chief.

CM Chisholm moved, seconded by CM Claridge to approve the contract with Tarrant County Fire Alarm. All voted "Aye".

13. SUBMISSION OF THE CITY'S GENERAL AND WATER FUND OPERATION BUDGET FY 2021 AS PRESENTED BY THE CITY MANAGER AND CALLING THE PUBLIC HEARING FOR ADOPTING THE FY 2021 CITY OPERATIONAL BUDGET.

We are planning on the Public Hearing for all budgets on August 25, 2020 along with the Property Tax Public Hearing. This budget includes a part time Emergency Management Coordinator, increase in the Fire Department staff to a 4-man shift, reduction in bulk pick up for landfill and labor costs and some employee raises. This does not include a 2% increase for the employees. The Fire Department part-time employees are not working out. We have employees that want to take time off and therefore, the overtime increases for someone to cover that shift. We are proposing of having Steve Sanders work 24 hours a week as the Building Inspector and the rest as a Fireman. Therefore, that would only leave us at hiring two new firemen. The part-time employees will go away. The Fire Department pay scale plan is comparable to the Police Department plan and includes all ranks.

CM Claridge moved, seconded by Mayor Pro Tem Ashton to call a Public Hearing for August 25, 2020 at 7:00 p.m. All voted "Aye".

OTHER ITEMS FOR DISCUSSION AND/OR ACTION:

14. UPDATE FROM EMC MYRICK ON WEST NILE VIRUS AND MOSQUITO SURVEILLANCE.

60% of mosquitos are testing positing in NE Tarrant County. Literature is being passed out to everyone who is in line at the food bank. There have been three positives that were in three different traps in River Oaks. No nests were found in the first positive. We are being notified at about 4 p.m. on a Friday of the positives which leaves us little time to schedule spraying. Signs are posted in the areas of the positive announcing the spraying.

Dickies Arena in Fort Worth and a place in Arlington are doing the saliva COVID-19 testing which is the most accurate test. An appointment is required, and test results are fast. Testing locations for the standard testing are moving around.
