#### CALL TO ORDER

With a quorum present, Mayor Earwood called the Regular Meeting of the River Oaks City Council to order at 7:00 p.m. on Tuesday, August 25, 2020 at the River Oaks City Hall, 4900 River Oaks Blvd., River Oaks, Texas 76114.

# PERSONAL APPEARANCES AND ITEMS REQUIRING COUNCIL APPROVAL/ACTION:

8. CONSIDER APPROVAL OF PROPOSAL FOR PROFESSIONAL CIVIL ENGINEERING WITH MJ THOMAS ENGINEERING LLC FOR CONCEPTUAL DRAINAGE STUDY OF ROBERTS CUT OFF RD TO CORNELL AVENUE TO BE EXPANDED FROM THE STORM WATER FUND AS RECOMMENDED FOR APPROVAL BY THE STORM WATER TASK FORCE.

The Storm Water Task Force approved to recommend to the City Council to approve the engineering and drainage study on Roberts Cut Off Road from Castleberry Cut Off Road to Cornell Avenue as proposed by MJ Thomas Engineering. The total engineering study cost is \$17,000.

# Mayor Pro Tem Ashton moved, seconded by CM Chisholm to approve the drainage study with MJ Thomas Engineering in the amount of \$17,000. All voted "Aye".

9. CONSIDER APPROVAL OF PROPOSAL FOR PROFESSIONAL CIVIL ENGINEERING WITH MJ THOMAS ENGINEERING LLC FOR ADDITIONAL SERVICES INVOLVING THE INSPIRATION LANE DRAINAGE STUDY TO BE EXPENDED FROM THE STORM WATER FUND AS RECOMMENDED FOR APPROVAL BY THE STORM WATER TASK FORCE.

October 15, 2019, Mickey Thomas presented the Storm Water Task Force with a proposed engineering solution and cost estimate from the survey information to address the drainage and street failures. The S.W.T.F. voted unanimously to approve the surveying and engineering on Inspiration Lane from Miller to the north end. In April 2020, Mickey Thomas presented a plan that included new curbs, paving and drainage design. The total additional services cost is \$12,700.

# CM Chisholm moved, seconded by CM Holland to approve the additional services with MJ Thomas Engineering in the amount of \$12,700. All voted "Aye".

10. DISCUSSION AND/OR ACTION ON PRESENTATION BY THE CITY MANAGER OF THE REVISED 5-YEAR GENERAL FUND BUDGET PLAN.

The 5-year updated plan was presented. We are currently in year 1. This plan does not include a full time Fire Chief. Council suggested if the roof needs to be replaced, to go ahead and put in in the plan.

# **PUBLIC HEARINGS/ACTION FROM PUBLIC HEARINGS:**

11. PUBLIC HEARING: IN ORDER TO RECEIVE PUBLIC INPUT ON THE PROPOSED 2020-2021 FISCAL YEAR OPERATING BUDGETS FOR THE CITY OF RIVER OAKS THAT WILL RAISE MORE TOTAL PROPERTY TAXES IN THE GENERAL FUND THAN LAST YEAR'S BUDGET BY \$93,308 DOLLARS OR 4.48% AND OF THAT AMOUNT \$20,458.97 IS TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR.

At 7:20 p.m., Mayor Earwood opened the Public Hearing.

General Fund Budget-Revenues are at \$6,022,837 and Expenditures are at \$6,022,837 which balances the budget. This budget includes a 30% cost reduction in the Event Center; closure of the Library; 2% salary increases to the employees that are not part of salary adjustments or pay scale plans; adds 3 new firefighters (Steve Sanders will fill one fire position and will remain as Building Inspector 24 hours a week); removes the part time firefighters; adds an Emergency Management Coordinator salary of \$24,000; there are some salary adjustments; the Fire Department cut some capital; removed the Fire Marshal position; and froze 1 position in Public Works.

At 7:33 p.m., Mayor Earwood closed the Public Hearing.

Water Sewer Fund Budget-Revenues are at \$3,441,000 and Expenditures are at \$3,441.00 which balances the budget.

Economic Development Budget-Revenues are at \$218,500 and Expenditures are at \$168,500 which is a \$50,000 surplus.

Crime Control Budget-Revenues are at \$208,550 and Expenditures are at \$236,895 which with \$28,345 in prior year funding, the budget balances.

Storm Water Budget-Revenues are at \$254,788 and Expenditures are at \$463,667 which with \$208,879 in prior year funding, the budget balances.

12. ACTION FROM PUBLIC HEARING: CONSIDER APPROVAL OF ORDINANCE #1290-2020 ADOPTING THE RIVER OAKS OPERATING BUDGETS FOR THE PERIOD OCTOBER 1, 2020 THROUGH SEPTEMBER 30, 2021.

Mayor Pro Tem Ashton moved, seconded by CM Chisholm to approve Ordinance #1290-2020. All voted "Aye".

13. PUBLIC HEARING: IN ORDER TO RECEIVE PUBLIC INPUT ON THE PROPOSED AD VALOREM 2020 PROPERTY TAX RATE IN THE CITY OF RIVER OAKS AT A RATE OF \$0.697375 PER \$100 OF PROPERTY VALUE WHICH IS EFFECTIVELY A TOTAL TAX RATE INCREASE OF \$0.022859/\$100 OF VALUE OR 3.39% FROM THE 2019 TAX RATE OF \$0.674516 PER \$100 OF PROPERTY VALUE. THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

At 7:43 p.m., Mayor Earwood opened the Public Hearing.

The no-new-revenue tax rate from the 2020 tax rate worksheet is 0.671699/\$100 (which would provide approximately the same amount of revenue as last year at a tax rate of 0.674516/\$100), and the voter-approval rate is 0.697375/\$100 (which is the maximum rate allowed by law without being subject to a mandatory election). The de minimis rate is 0.834124/\$100 that is calculated using the 2020 total taxable value of 311,853,193. The rate necessary to impose 0.000 in taxes is 0.160331. To calculate the de minimis rate you take the maintenance and operations tax rate of 0.673793/\$100 + 0.160331 = 0.834124/\$100. With a 0.000 projection rate, the projected revenue will be 0.000

At 7:55 p.m., Mayor Earwood closed the Public Hearing.

Mayor Pro Tem Ashton moved, seconded by CM Chisholm to hold a Public Hearing on September 1, 2020 at 6:00 p.m. All voted "Aye".
