8. CONSIDER APPROVAL UNDER THE FAIR HOUSING ACT TO MAKE A REASONABLE ACCOMMODATION FOR A PERSON WITH A DISABILITY WITH REGARD TO LAND USE REGULATIONS AS REQUESTED BY ZENAIDA TOVAR BANDA AT 1401 WESTWICK DR. IN ORDER TO BE PERMITTED TO BUILD A 14' X 20' CARPORT IN FRONT ATTACHED TO THE EXISTING FRONT PORCH AWNING IN THAT THE PROPOSED CARPORT WOULD EXTEND IN FRONT OF THE 25-FOOT BUILDING LINE TO WITHIN 6'9" OF THE PREVAILING EDGE OF THE STREET IN VIOLATION OF SECTION 22.A.5D OF THE RIVER OAKS ZONING ORDINANCE.

Zenaida Tovar Banda was present. Requesting a carport to load a disabled child in the vehicle so he would not be in the weather elements. There is no other location that this carport can be built at on this property. The Zoning Board of Adjustments could not rule because it was out of the scope of allowable hardships. But can be brought before the council as reasonable accommodation by the Fair Housing Act. If this carport is built in the right-of-way and utility companies must come in, they can tear down part of the carport to access the right-of-way. This carport will be attached to the house under the roof line, the poles will be stucco to match the house, and the roof will have shingles to match the house. The poles will not be in the right-of-way but the 2' overhang will. CM Gregory wants to record this downtown to show on the title work. All the notifications sent out were in favor of this request.

Mayor Pro Tem Claridge moved, seconded by CM Rodriguez to approve the reasonable accommodations based on disability and it does not create an unreasonable hardship for the city that the carport can be built up to 15' in front of the build to line on the property and 10' from the prevailing edge of the street with up to a 2' roof overhang and that the improvements could remain on the property even if the applicant leaves the property. All voted "Aye".

9. CONSIDER APPROVAL OF THE 2021-2022 FISCAL YEAR AUDIT REPORT AS PRESENTED BY MWH GROUP, CERTIFIED PUBLIC ACCOUNTANTS.

This item has been tabled to the November 14, 2023 council meeting.

10. DISCUSSION AND/OR ACTION ON SUBSTANDARD BUILDING ORDER ON THE PROPERTY AT 4844 HARTFORD THAT WAS PREVIOUSLY EXTENDED TO SEPTEMBER 21, 2023.

Mr. Purvis was not present. Have not heard if the house is finished. Recommend extending this to the October 24, 2023 council meeting.

Mayor Pro Tem Claridge moved, seconded by CM Rodriguez to extend the building order to the October 24, 2023 council meeting. All voted "Aye".

11. CONSIDER APPROVAL OF THE RULES AND PROCEDURES OF THE PLANNING & ZONING COMMISSION AS AMENDED.

Currently, Brad Gallman is the Vice Chairman, and he is the Place 5 Member and that would not be in accordance with the existing Rules and Procedures where he should be Place 2 and that would end up having the other places re-appointed. The board requested that the Rules and Procedures be revised removing the requirement for the Vice-Chairman be Place 2.

Mayor Pro Tem Claridge moved, seconded by CM Turner to approve the Rules and Procedures with the additional changes as discussed. All voted "Aye".

ORDINANCES/RESOLUTIONS REQUIRING COUNCIL APPROVAL/ACTION:

- 12. CONSIDER APPROVAL OF ORDINANCE #1389-2023 AMENDING ARTICLE 13.03 "WATER SYSTEM", SECTION 13.03.011 "WATER RATES" OF THE RIVER OAKS CODE OF ORDINANCES (2020) AS AMENDED; ADOPTING AND RATIFYING FEES FOR WATER RATES INSIDE AND OUTSIDE THE CITY LIMITS; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.
- 1.7% water rate decrease for the minimum base water rates of commercial customers in and out of the water district from \$29.50 to \$29.00; 1.2% water rate decrease for the minimum base water rates of commercial customers in and out of the water district from \$42.00 to \$41.50; 1.97% water rate decrease for the minimum base water rates of commercial customers outside of the city and inside the water district from \$52.00 to \$51.00; 3.7% water rate decrease for the usage charge of residential customers outside of the city and in the water district from \$0.1400000 to \$0.13500000 per cubic foot for usage over 400 cubic feet; and 3/6% water rate decrease for the usage charge of commercial customers outside of the city and in the water district from \$0.145000 to \$0.1400000 per cubic foot for usage over 400 cubic feet.

Mayor Pro Tem Claridge moved, seconded by CM Rodriguez to approve Ordinance #1389-2023. All voted "Aye".

13. CONSIDER APPROVAL OF ORDINANCE #1390-2023 AMENDING ARTICLE 13.04 "SEWER SYSTEM", SECTION 13.04.013 "SEWER SERVICE RATES", OF THE RIVER OAKS CODE OF ORDINANCES (2006) AS AMENDED; ADOPTING AND RATIFYING SEWER RATES INCORPORATING A RATE INCREASE FOR RESIDENTIAL, COMMERCIAL AND APARTMENT CUSTOMERS INSIDE AND OUTSIDE THE CITY LIMITS.

There is a 13.7% system wide average increase in the residential rates, which is an increase of \$4.50 in base rate from the current \$40.00 to \$44.50 and a usage rate increase of .50 cents for every 100 cubic feet. Commercial customers are billed for actual water usage and are being increased 11.8% this year on retail base rates from \$58.00 to \$63.00 plus an additional 14.47% in usage charges and apartments from \$54.00 to \$59.00 plus 15% in usage charges.

Mayor Pro Tem Claridge moved, seconded by CM Rodriguez to approve Ordinance #1390-2023. All voted "Aye".

14. CONSIDER APPROVAL OF ORDINANCE #1391-2023 AMENDING THE GENERAL FUND BUDGET BY EXPENDING PARK DOLLAR DONATIONS FOR THE PURCHASE OF A BOTTLE FILLER (DRINKING FOUNTAIN) AT MCGEE PARK.

This bottle filler will be by the concession stand next to the playground. The Park Board recommended this purchase not to exceed \$4,300.00.

CM Turner moved, seconded by Mayor Pro Tem Claridge to approve Ordinance #1391-2023. All voted "Aye".
