This is a standard yearly agreement.

# CM Claridge moved, seconded by CM Rodriguez to approve the 2023 Ercot Membership and Agreement. All voted "Aye".

10. CONSIDER ACTION TO OVERTURN THE AUGUST 9, 2022 COUNCIL DECISION TO ENTER INTO AN INTERLOCAL AGREEMENT WITH THE CITY OF FORT WORTH ON THE SKYLINE DRIVE WATER LINE RECONSTRUCTION IMPROVEMENTS PROJECT IN ORDER TO INSTALL A 16-INCH WATER MAIN THAT PROVIDES POTABLE WATER FROM THE CITY OF FORT WORTH TO THE EMERGENCY CONNECTION THAT SERVES RIVER OAKS.

Council agreed to drop out of the project and use the funds for the Water Treatment Plant project.

CM Holland moved, seconded by CM Claridge to deny entering into an ILA with the City of Fort Worth for the Skyline project. All voted "Aye".

11. CONSIDER APPROVAL OF ORDINANCE #1363-2022 AMENDING CHAPTER 13 "UTILITIES", ARTICLE 13.02 "UTILITY POLICY" UNDER DIVISION 2 "WATER SERVICE POLICY" SPECIFICALLY UNDER SECTION 13.02.038 "WAIVER OF CHARGES; ADJUSTMENTS OF BILL" OF THE RIVER OAKS CODE OF ORDINANCES (2020) AS ADOPTED AND AS AMENDED.

This will eliminate the good credit part and apply some new rules. The customer will have a 60-day window to pull permits and to get the repairs done and have the work inspected. If a permit is required, the permits must be obtained by a licensed and River Oaks registered plumber. Council agreed to remove in the Ordinance #8, #IV.

# CM Claridge moved, seconded by Mayor Pro Tem Chisholm to approve Ordinance #1363-2022 as amended. All voted "Aye".

We need to include both papers as the official papers to River Oaks.

Mayor Pro Tem Chisholm moved, seconded by CM Rodriguez to approve Ordinance #1364-2022. All voted "Aye".
