8. CHRIS MILLER REPRESENTING Q-TEL, LTD REQUESTING SPECIAL PERMISSION TO ADD ICE VENDING UNIT TO THE EXISTING WATER KIOSK AT 5504 RIVER OAKS BLVD. THAT WAS PREVIOUSLY APPROVED BY SITE PLAN APPROVAL ON MARCH 11, 2008.

Chris Miller was present. This ice machine is located at the intersection of Yale and River Oaks Blvd. This was a water vending building, and an ice unit was added next to the current building. Received a letter from the city that council originally approved this for water only. The ice machine is about the size of a soda vending machine. If we must remove the ice machine, we may have to shut it all down completely. The current building is $10' \times 10'$ and there is no room inside to put the ice machine. Council agreed to work with staff for a site plan amendment and the ice machine can stay until meetings are set up.

CM Holland moved, seconded by CM Claridge to table this item until January 24, 2023 at 6:00 p.m. for site plan approval. All voted "Aye".

9. CONSIDER APPROVAL OF REQUEST FROM JOCELYNE CORRALES, PRESIDENT SKILLS USA CHS, HOLDING THE PAWS DOGGY HUNGER EVENT AT THE COMMUNITY CENTER ON DECEMBER 3, 2022 AND REQUESTING CITY PARTICIPATION PERTAINING TO THE BENEFIT "DON'T FORGET TO FEED ME".

Jocelyne Corrales, Bryan Rufus and Abby Flores were present. Paws Doggy Hunger is sponsored by Castleberry High School-Skills USA/DECA. This food drive will be on December 3rd, 2022 from 10:00 a.m. to 5:00 p.m. at the River Oaks Event Center. They are offering a free \$40.00 package in exchange for 10 pounds packed/sealed dog food. The package includes a free nail trim, teeth brushing, breath spray, bandana, and a treat bag with a personalized paw print ornament. On

November 28, 2022, they will be accepting donations at the school. On December 3rd, there is also a craft fair at the center. Wants the city to be a sponsor to help advertise the event and allow to put donation boxes around our city.

Mayor Pro Tem Chisholm moved, seconded by CM Claridge to approve the city's participation of Paws Doggy Hunger on December 3, 2022 by advertising this on the city's website and allow a box to be put in City Hall and to find that this is a public purpose. All voted "Aye".

At this time, Mayor Ashton stepped in.

10. CONSIDER APPROVAL REVISING THE REQUEST FOR DISCRETIONARY FUNDS FROM TARRANT COUNTY UNDER THE 2006 TRANSPORTATION BOND FOR RIVER OAKS STREET IMPROVEMENTS AS ORIGINALLY APPROVED ON NOVEMBER 8, 2022.

This was presented at a previous meeting. Since costs have increased, the city's part would be \$295,315.05. Will need the Mayor to sign the ILA and to send a revision letter in.

CM Holland moved, seconded by Mayor Pro Tem Chisholm to revise the request for discretionary funds from the 2006 Transportation Bond. All voted "Aye".

11. PUBLIC HEARING: IN ORDER TO RECEIVE PUBLIC INPUT ON SUBSTANDARD BUILDING ENFORCEMENT ACTION REGARDING STRUCTURE(S) LOCATED ON THE PROPERTY AT 4844 HARTFORD.

At 6:46 p.m., Mayor Ashton opened the Public Hearing.

No one was present. An administrative search warrant was issued. No abatement was received, and letters were returned to the city as undelivered. CM Gregory went over the substandard list and showed pictures. House has been vacant for about six months. No plan of action has been received but the house is feasible of repair.

At 6:56 p.m., Mayor Ashton closed the Public Hearing.

12. Looks like letters were sent to a Fort Worth address and a Kansas address. Need to verify if we did send the notice to the correct address and if not, need to re-notice it to the correct address. No action will be taken until it is re-noticed and will be re-scheduled for the December 13th, 2022 Council Meeting.

13. PUBLIC HEARING: IN ORDER TO RECEIVE PUBLIC INPUT ON SUBSTANDARD BUILDING ENFORCEMENT ACTIN REGARDING STRUCTURE(S) LOCATED ON THE PROPERTY AT 1909 YALE STREET.

At 7:00 p.m., Mayor Ashton opened the Public Hearing.

Thomas Williamson and Attorney Faun Bailey was present. A lot of cleanup is going on at this property, the accessory building has been removed, and the fence has been removed and partially replaced by the neighbor. May take 120-180 days to repair or to sell because of the holidays. There is a potential buyer, but it needs to be surveyed.

At 7:16 p.m., Mayor Ashton closed the Public Hearing.

14. ACTION FROM PUBLIC HEARING: CONSIDER COUNCIL ORDERS ON THE PROPERTY AT 1909 YALE STREET THAT MAY INCLUDE SECURING, VACATING OF OCCUPANTS, REMOVAL, REPAIRING OR DEMOLITION OF STRUCTURE(S) OR ADOPTION OF RESOLUTION IMPLORING A FEDERAL AGENCY TO ABATE ALL SUBSTANDARD VIOLATIONS IN ORDER TO BE BROUGHT INTO COMPLIANCE WITH SECTION 3.07.004 OF THE RIVER OAKS CODE OF ORDINANCES (2006) AS AMENDED.

CM Holland moved, seconded by CM Claridge that the City Council finds that the building located at 1909 Yale based on evidence presented at this hearing, is substandard and: 1) that the conditions set forth in the Building Official's report exist to the extent that the life, health, property, or safety of the public (and occupants of the building(s), if applicable are endangered; and 2) that the building(s) is/are feasible of repair and therefore order the building to be repaired by the owner within 89 days and the lienholder or mortgagee to within an additional 30-days if the owner does not comply; and 3) the board orders commencement of the repairs within 30days and to establish specific time schedules with the owner or mortgagee for the 4) order that the building be repaired in conformance with the requirements of Section 3.07.004 of the River Oaks Code of Ordinances (2006) as amended or demolished by the owner and the debris removed within 89 days or by the lienholder or mortgagee to within an additional 30-days if the owner does not comply and further find that if the building is not repaired within 89 days, that there is no reasonable probability that the building will be repaired within a reasonable period of time if additional time is given. If the building is not repaired within 89 days in full conformance with Section 3.07.004 of the River Oaks Code of Ordinances (2006), the building shall be demolished; and 5) order that a substandard fee of \$150.00 be paid upon permit issuance. Certificate of Occupancy may not be finaled until all substandard fees are paid in full. All voted "Aye".

ORDINANCES/RESOLUTIONS REQUIRING COUNCIL APPROVAL/ACTION:

EDC authorized to spend \$2,525.00 out of the promotional account for Christmas lights on the City Hall complex. The cost includes purchasing of the lights and labor.

Mayor Pro Tem Chisholm moved, seconded by CM Holland to approve Ordinance #1365-2022. All voted "Aye".

16. CONSIDER APPROVAL OF RESOLUTION #1095-2022 AMENDING ARTICLE V "LEAVE POLICIES" SPECIFICALLY IN SECTION 5.01 "HOLIDAYS" BY REVISING THE SECTIONS IN REGARD TO "HOLIDAYS DESIGNATED"; "SUBSTITUTE HOLIDAYS"; "DESIGNATED HOLIDAYS FOR FIRE DEPARTMENT SHIFT EMPLOYEES" AND REVISING "DESIGNATED HOLIDAYS FOR OTHER SHIFT EMPLOYEES"; REMOVING THE SECTION "PERSONAL HOLIDAY; NEW EMPLOYEES" FROM SECTION 5.01 AND RENUMBERING SAID SECTIONS ACCORDINGLY.

The main purpose of this is all the city's employees are not on the same shift. We have some that are 8 hours, 9 hours, 10 hours, and 12 hours. The Fire Department already has the holiday hour section, and it is working well. All the holiday hours will be entered in on October 1st of each year and the balance as of September 30th of each year will be removed. We are requesting to add Juneteenth which would make 14 holiday hours which include two personal holidays.

CM Claridge moved, seconded by CM Turner to approve Resolution #1095-2022. All voted "Aye".
