Planning and Zoning has had several workshops and has even had a joint workshop with the council. The consensus is to allow new and second hand merchandise to all retail businesses; remove the masonry requirements; change outside storage in businesses to 50% can be stored outside; set regulations in automobile laundry and remove from C-3 and add to C-2; for pawn shops the new owner would have to put up screened fencing if they leave merchandise out all the time (only if new ownership); added craft fairs and all would have to have council approval; remove from C-2: automotive repair shops, retail tire shops, laundry and washaterias, body piercing, tattoo shops, massage establishments, pawn shops, cigar and tobacco stores including retail establishments primarily selling vape or vaping devices, predatory lending businesses including check cashing businesses, payday advance/loan businesses, and car title businesses (excluding state or federally chartered banks, savings and loan associations or credit unions), and automated teller machines not associated with a primary use on the property.

Also defined is Automobile Repair Garages to mean a building, shop or place where vehicular repairs are performed on cars, trucks, vans, motorcycles, heavy equipment, oversized vehicles and any other motor powered equipment when deemed by the Zoning Administrator to be a motorized, self-propelled vehicle including but not limited to tire shops, paint and body shops, transmission shops, muffler shops, and engine overhauling but does not include upholstery shops, tinting shops, glass replacement, automotive parts and express oil changing and lube stations.

C-2 is River Oaks Blvd and C-3 is Jacksboro Hwy.

11. ACTION FROM PUBLIC HEARING: CONSIDER APPROVAL TO ADOPT ORDINANCE #1394-2023 AMENDING THE COMPREHENSIVE ZONING ORDINANCE #1331-2021 BY APPROVING THE PROPOSED 2023 ZONING TEXT AMENDMENTS (CASE #PZ 2023-002).

The rules were summarized on some of the items presented and mentioned that some businesses can continue but may have to go before the Planning & Zoning. The ATM was meant for if the business was gone. The consensus was to remove the ATM section. The consensus was to take automobile laundry out of C-2 and put in C-3.

CM Holland moved, seconded by CM Rodriguez to approve Ordinance #1394-2023 with changing automobile laundry from C-2 to C-3, remove the ATM restriction from C-2, and have the City Manager approve farmers markets. All voted "Aye".

12. PUBLIC HEARING: IN ORDER TO RECEIVE CITIZEN COMMENTS ON ADOPTING ORDINANCE #1392-2023 AMENDING THE RIVER OAKS CODE OF ORDINANCES UNDER CHAPTER 13 "UTILITIES" BY REVISING THE STORM WATER UTILITY FEES AS SET FORTH IN CHAPTER 13 "UTILITIES" OF THE RIVER OAKS CODE OF ORDINANCES (2020) AS AMENDED, SPECIFICALLY IN SECTION 13.12.012 "STORM WATER UTILITY FEES" FOR RESIDENTIAL AND NON-RESIDENTIAL CUSTOMERS.

Recommendation from the Storm Water Task Force is to raise the residential rate from \$6.00 a month to \$7.00 a month. The commercial from \$.00266 per square foot to \$.00310 per square foot.

James Myrick-Storm Water Board Member (5825 Meandering): if we did not pass the fees when we did, we would not have been able to do the projects that we have done to improve drainage.

There has never been electricity at this park. Needs a meter base, meter box, lines for the sprinkler system, guard light, and electrical outlets. Bunch Electric was the cheapest at \$10,480.00 and he has done a lot of work for the city for many years. All of this work has to be done at the same time. The Park Board requested this years ago and the current Park Board would like to do this project. But the Park Board does not want to pay for this out of their \$1 donation account. This project was not budgeted, and we would have to go into reserves for this.

Motion failed due to lack of a motion.

By adopting the 2018 International Codes, our rating would go back to a Class 4. Received confirmation that if we did upgrade to the 2018 International Codes, our rating would be re-evaluated, and we should go back to a Class 4.
