8. CONSIDER APPROVAL OF REQUEST FROM LISA FULD AT 1844 INSPIRATION LANE TO PURCHASE FROM THE CITY THE REMAINING 0.1715 ACRES NOT INCLUDED WITH THE SEPTEMBER 2020 PURCHASE FROM THE CITY OUT OF THE ORIGINAL 0.3221 ACRES IN THE J.D. QUINN SURVEY.

At 6:05 p.m., Mayor Ashton went into Executive Session under Section 551.071.

At 6:14 p.m., Mayor Ashton reconvened into Open Session.

Lisa Fuld was present. The request is to purchase the remaining of the 0.3221 acres. 0.1506 acres was previously purchased by the Fuld's. What is left to purchase is .1715 acres and the appraisal from two years ago was \$6,000.00. The city will need a full-size plat to record at the county. If council approves, will have to bring back an ordinance at the next meeting.

CM Chisholm moved, seconded by CM Claridge to approve selling 0.1715 acres to the Fuld's with the buyer paying all closing costs and the buyer will have to provide a full-size plat to the city. All voted "Aye".

ORDINANCES/RESOLUTIONS REGARDING COUNCIL APPROVAL/ACTION:

9. CONSIDER APPROVAL OF ORDINANCE #1339-2022 AMENDING ARTICLE 8.07 "PETS INSIDE MUNICIPAL BUILDINGS".

Blythe Reaves was present. Blythe has trained service dogs since 1994. Right now, no animals are allowed inside City Hall. We need to allow animals in the building if they are service animals. We can not ask why a person needs to bring a dog inside. Would prefer if the owner of the animal has something on the animal saying it is a service animal. Added in this ordinance is if a

person brings in an animal and that animal injures someone, the city is not liable. It is the owner's responsibility. We need to change the sign on the door saying something like "Only Service Animals Allowed".

Mayor Pro Tem Houk moved, seconded by CM Chisholm to approve Ordinance #1339-2022 pending approval from the City Attorney. All voted "Aye".

WORK SESSIONS:

12. DISCUSS THE FUTURE OF THE ECONOMIC DEVELOPMENT CORPORATION (EDC) AND ITS SALES TAX.

CS Luck reached out to Lake Worth and Haltom City. Lake Worth responded and after the election, they reallocated the 4B tax of .50% to the General Fund along with Street Maintenance tax of 0.25%. The 4B EDC did not carry any debt so the fund balance can be expensed on various projects.

To reallocate the EDC sales tax, we will have to hold and election. It was suggested that we make EDC a department in the General Fund. Right now, EDC's bank balance is over \$600,000.00. It also was suggested that we need a part-time employee as an EDC Coordinator and to relieve the job duties from City Manager Gregory.

Council agreed to hold off for several months or even a year to think about what needs to be done. We can wait and have this election in May 2023 with our City Council election if that is the direction council wants to go.

13. CONSIDER REVISIONS OF THE CITY'S SIGN ORDINANCE AS CODIFIED IN ARTICLE 3.12 "SIGNS" OF THE RIVER OAKS CODE.

The areas we have been working on are highlighted for council to review. The portable signs seem to be a problem. Brent Forrester of 5601 James Drive suggested maybe to allow the portable signs twice a year. Council agreed to allow portable signs for 30 consecutive days once a year for any business and to treat grand opening signs and regular portable signs separately.

Attached signs on building would like to change to 75% of the building can have a sign but 25% of the building remains open.

Political Signs are only permitted two weeks prior to the start of early voting. Council would like to see no limit on political signs.

This ordinance will be brought back on March 8th with the changes and some clean up.

Police Department have three vacant officer positions and one vacant dispatch position. In process of hiring a dispatcher. Sansom Park is hiring officers at about \$9,000.00 more than what we start at. Every city no matter the size is experiencing officer shortages. We need to look at a permanent animal control facility and start raising funds. Mayor Ashton and CM Gregory has had a meeting with Todd with the YMCA and will be meeting with Todd again soon. Citizen Brent Forrester has seen a lot of negative comments on the water quality. The city has replaced a lot of water and sewer lines and are in the process of replacing the roads. The city has not had a bad water report in many years.
