At this time, Mayor Ashton discussed Item #10.

Renee Faulkner Smith was present. Appreciates the Mayor and Council for attending the ballfield dedication. The campaign for next year is "Leading the Way". Other districts are losing enrollment, but CISD is gaining enrollment. We need to continue to advertise enrollment. Would like to hang banners for Back the School Bash, Lions Night, LYSA and Homecoming. It was mentioned about a full banner running across the whole street but not sure if TXDOT would allow. The school can supply a plan on working with the city on installing and taking down the banners.

CM Holland moved, seconded by Mayor Pro Tem Chisholm to approve the request from CISD for street light banners. All voted "Aye".

8. CONSIDER APPROVAL OF REQUEST TO HOLD A POLICE FORCE ESCORTED CRUISE ON APRIL 21, 2023 AS A CITY SPONSORED EVENT.

The route is the same as last year but with a small change on the route.

CM Claridge moved, seconded by CM Rodriguez to approve the police force escorted cruise as a city sponsored event on April 21, 2023. All voted "Aye".

9. CONSIDER APPROVAL AWARDING BID FOR THE PHASE I RED OAK DRAINAGE & PAVING IMPROVEMENT PROJECT #619-021 FROM THE SEALED BIDS RECEIVED AND PUBLICLY READ ALOUD ON MARCH 24, 2023 AT 2:00 P.M.

Mickey Thomas was present. Two bids were received: TexPro Construction for \$69,744.05 and Apple Pavement Services for \$119,424.05. Recommended is TexPro Construction.

CM Holland moved, seconded by Mayor Pro Tem Chisholm to award the bid to TexPro Construction in the amount of \$69,744.05 for the Red Oak Project Phase I. All voted "Aye".

10. CONSIDER APPROVAL OF REQUEST FROM CISD SUPERINTENDENT RENE SMITH FAULKNER UTILIZING THE EXISTING STREET LIGHT BANNER POLES TO ADVERTISE CASTLEBERRY ISD DURING BACK TO SCHOOL AND HOMECOMING.

11. DISCUSSION AND/OR ACTION UPDATING PROGRESS ON THE SUBSTANDARD BUILDING AT 1909 YALE STRET AS EXTENDED ON FEBRUARY 28, 2023.

Representation on this property showed up at 6:00 p.m. instead of 7:30 p.m. CM Gregory will be meeting with the potential new owner tomorrow. Should be able to close on the property next week. The substandard fee is paid, and the permits are pulled.

Mayor Pro Tem Chisholm moved, seconded by CM Rodriguez to not to take enforcement action until the April 11, 2023 council meeting. All voted "Ave".

12. CONSIDER APPROVAL TO AMEND AND REVISE THE PLANNING & ZONING RULES AND PROCEDURES ORIGINALLY APPROVED ON APRIL 19, 2004.

The issue is getting a quorum of four members to conduct a meeting. So changed the quorum to three members; changed rules of order to Rosenberg's Rules of Order; changed the current adopted ordinance to #1331-2021; added ethics ordinance #950-2012; include from subdivision ordinance the sections applicable; changed wordings to City Manager; replaced Exhibit A & B to current Applications; and changed amendments to the Rules & Procedures can be recommended by the commission but final approval is the City Council.

CM Claridge moved, seconded by Mayor Pro Tem Chisholm to approve the amended Planning & Zoning Procedures. All voted "Aye".

13. CONSIDER APPROVAL OF ORDINANCE #1373-2023 AMENDING THE FY 2022-2023 STORM WATER FUND BUDGET BY EXPANDING THE STORM WATER FUND BUDGET IN ORDER TO EXPEND UNPLANNED FUNDS FOR CONSULTANT FEES, DRAINAGE MAINTENANCE, AND TRAINING.

The increased are due to the Red Oak project and training. Requesting is \$93,000.00 in budget amendments. The Texas Water Development Board has a new program called "Storm" which would help with drainage.

CM Claridge moved, seconded by CM Rodriguez to approve Ordinance #1373-2023. All voted "Aye".
