1. CALL TO ORDER

With a quorum present, Mayor Pro Tem Chisholm called the Regular Meeting of the River Oaks City Council to order at 6:00 p.m. on Tuesday, April 11, 2023 at the River Oaks City Hall, 4900 River Oaks Blvd., River Oaks, Texas 76114.

2. INVOCATION

CM Rodriguez delivered the Invocation.

CM Rodriguez led the Pledges of Allegiance to the United States and the Texas Flags.

CM Claridge moved, seconded by Mayor Pro Tem Chisholm to approve the Consent Agenda Items #A-C. All voted "Aye".

7. DISCUSSION OR ACTION TAKEN ON ITEMS WITHDRAWN FROM CONSENT AGENDA FOR SEPARATE DELIBERATION.

The revised agreement was sent out by email. The total cost for the project is \$9,500.00 (\$4,750.00 is the city's part). The painting cost was reduced. Receipts, invoices, the affidavit form from the property owner, and the tax certificate will need to be turned in.

CM Claridge moved, seconded by Mayor Pro Tem Chisholm to approve Item #D with the noted changes. All voted "Aye".

PERSONAL APPEARANCES AND/OR ITEMS REQUIRING COUNCIL APPROVAL/ACTION:

8. CONSIDER APPROVAL OF MEMORANDUM OF UNDERSTANDING (MOU) FOR EMERGENCY SHELTERING AT THE RIVER OAKS COMMUNITY CENTER BETWEEN CISD AND THE CITY.

Our City Attorney has reviewed the MOU and has made recommendations. The revised MOU was sent over to CISD and they have signed it.

Mayor Pro Tem Chisholm moved, seconded by CM Claridge to approve the MOU between CISD and the city. All voted "Aye".

9. CONSIDER APPROVAL TO EXTEND, AMEND, MODIFY OR ISSUE SUBSEQUENT ORDERS IN ORDER TO ABATE ALL SUBSTANDARD VIOLATIONS ON THE PROPERTY AT 1909 YALE STREET FROM THE NOVEMBER 22, 2022 COUNCIL ORDER THAT MAY INCLUDE SECURITY, VACATING OF OCCUPANTS, REMOVAL, REPAIRING OR DEMOLITION OF STRUCTURE(S) IN ORDER TO BE BROUGHT INTO COMPLIANCE WITH SECTION 3.07.004 OF THE RIVER OAKS CODE OF ORDINANCES (2020) AS AMENDED).

Talked with the title company, and just waiting for the closing date. The 30 days is up, and staff recommends postponing this to the April 25th, 2023 Council Meeting. A lot of work has been done on the outside.

CM Claridge moved, seconded by CM Rodriguez to allow a 14-day extension and for staff not to enforce. All voted "Aye".

10. DISCUSSION AND/OR ACTION ON TEXAS EMISSIONS REDUCTION PROGRAM (TERP) EQUIPMENT REPLACEMENT REBATE GRANT THROUGH THE TEXAS COMMISSION OF ENVIRONMENTAL QUALITY (TCEQ) FOR PURCHASING TWO BACKHOES.

This is an extension of the previous grant. We have a 1994 backhoe that is eligible for a \$96,000.00 rebate and we have a 2006 backhoe that is eligible for a \$74,000.00 rebate. Total price for two new backhoes is \$260,444.24 with \$170,006.00 towards the grant, and the city's cost is \$90,438.24. We submitted the application last week because we had a small window to get it submitted. The engine blocks will be destroyed on the old backhoes, and we will scrap the rest. One backhoe will be paid out of the General Fund and the other one will be paid out of Water Sewer. These new backhoes are the same size as our current ones and will continue to meet our needs.

CM Claridge moved, seconded by CM Rodriguez to submit the applications. All voted "Aye".

ORDINANCES/RESOLUTIONS REQUIRING COUNCIL APPROVAL/ACTION:

11. CONSIDER APPROVAL OF ORDINANCE #1374-2023 AMENDING CHAPTER 4 "BUSINESS REGULATIONS" OF THE CODE OF ORDINANCES, CITY OF RIVER OAKS, TEXAS BY ADDING AN ARTICLE 4.10 "BOARDING HOMES" ESTABLISHING THE INSPECTION, REGISTRATION AND PERMITTING OF BOARDING HOMES, AND ESTABLISHING ENFORCEMENT AUTHORITY; PROVIDING RECORD KEEPING REQUIREMENTS.

This ordinance is to set up the permit process, regulate the homes, and have them documented. Right now, if a person wants to have a boarding home, we cannot say no. The cost for this permit will be \$1,500.00. There will only be one home allowed within a 1/2 mile radius. This is not the same as the Air B & B which we may need to go ahead and get that ordinance together for regulations.

The City of Fort Worth is about to start enforcing their ordinance and when they do, the people will go to other cities.

CM Claridge moved, seconded by CM Rodriguez to approve Ordinance #1374-2023. All voted "Aye".

12. CONSIDER APPROVAL OF THE MID-YEAR FY 2022-2023 OPERATIONAL CITY BUDGETS AS PRESENTED BY THE CITY MANAGER AND APPROVAL OF ORDINANCE #1375-2023 AMENDING THE FY 2022-2023 FISCAL YEAR BUDGETS.

At this time, Mayor Ashton stepped out for a minute and Mayor Pro Tem Chisholm will take over the meeting until he returns.

We were able to move money around within the departments but were unable to move some money around and need to make budget adjustments. This is the least amount we have asked for in mid-year adjustments in a while. In General Fund, we have collected 61.19% and expended 46.85%. In Water Sewer, we have collected 46.51% and expended 46.85%. We are asking for \$40,932.67 in adjustments in the General Fund, and \$26,100.00 in adjustments in the Water Sewer.

CM Claridge moved, seconded by Mayor Pro Tem Chisholm to approve Ordinance #1375-2023. All voted "Aye".

13. CONSIDER APPROVAL OF ORDINANCE #1376-2023 AMENDING CHAPTER 13 "UTILITIES" ARTICLE 13.03 "WATER SYSTEM", SECTION 13.03-009 "METER DEPOSITS & OTHER FEES", SUBSECTION (a) "WATER METER DEPOSIT" OF THE RIVER OAKS CODE OF ORDINANCES (2020) AS AMENDED CHANGING THE DEPOSIT FEE FOR CONSTRUCTION FIRE HYDRANT METERS FROM \$1,000 TO \$2,000 WITH CERTAIN CONDITIONS.

Currently we have no criteria. We are requesting the deposit amount to be \$2,000.00 to cover the cost of a new meter, a service fee of \$30.00, and a monthly rental fee of \$50.00. The meters will also be ran through our system so they will be billed monthly.

CM Holland moved, seconded by CM Claridge to approve Ordinance #1376-2023. All voted "Aye".

OTHER ITEMS FOR DISCUSSION AND/OR ACTION:

At this time, Item #15 will be discussed. The fireworks will be scheduled for June 24th at Victory Church, and they will participate in the fireworks like they have done in the past.

CM Holland moved, seconded by Mayor Pro Tem Chisholm to approve this year's All-American Festival for June 24th. All voted "Aye".
