CM Claridge moved, seconded by CM Chisholm to approve the Consent Agenda Items #A-B. All voted "Aye".

7. DISCUSSION OR ACTION TAKEN ON ITEMS WITHDRAWN FROM CONSENT AGENDA FOR SEPARATE DELIBERATION.

Item #C: Council wanted the Town Hall Meeting Minutes revised.

CM Claridge moved, seconded by CM Chisholm to approve Item #C with revisions. All voted "Aye".

PERSONAL APPEARANCES AND/OR ITEMS REQUIRING COUNCIL APPROVAL/ACTION:

8. CONSIDER APPROVAL OF REQUEST FROM CASTLEBERRY HIGH SCHOOL 2022 SENIOR CLASS TO HOLD A PARADE AS A CITY SPONSORED EVENT.

Steve Sanders presented a request for the Class of 2022 parade to raise funds for prom, the senior breakfast, and the after-graduation event for the 2022 Class. A parade has been done the last three years and would like to make this an annual event. The route is on residential streets. Police Chief Spieldenner has no problems with this if CISD can provide officers also.

CM Claridge moved, seconded by CM Rodriguez to allow the parade for the Class of 2022 and to make this an annual event and to get with city staff in the future 30 days before the parade. All voted "Aye".

9. CONSIDER APPROVAL OF LEASE AND MAINTENANCE AGREEMENT FOR A COM COLOR 3150 INK JET IMAGING DEVICE AS PRESENTED BY REED MELNICK OF POP SMART TECHNOLOGIES.

Reed Melnick was present. The current printer was damaged by water from a roof leak. The printer has been fixed at no cost to us. But the printer was not able to print the water bills without issues. The current printer uses toner which produces heat which causes jamming. The proposed printer used inkjet with no heat. This printer will also print everything on the water bill. Currently we order the paper with a template pre-printed on them. The new printer will print everything cheaper than what we are paying now for printing. The savings will be \$200 per month. The savings per year is about \$7,662.60. This new printer also can print on brown envelopes for evidence that the Police Department use. The city does not have to buy out the current lease.

CM Chisholm moved, seconded by CM Claridge to approve the lease agreement with Pop Smart Technologies subject to City Attorney approval. All voted "Aye".

10. APPROVE JOINT ELECTION AGREEMENT AND CONTRACT FOR ELECTION SERVICES WITH TARRANT COUNTY ELECTIONS FOR MAY 7, 2022 GENERAL ELECTION.

Prices have increased since last year. Council questioned our costs compared to other cities. CM Gregory will contact Tarrant County and check into it.

CM Claridge moved, seconded by CM Rodriguez to approve the contract with Tarrant County Elections and to have CM Gregory check into the final costs. All voted "Aye".

11. DISCUSSION AND/OR ACTION ON APPLYING HAS HIGH DENSITY MINERAL BOND TO THE NEW ASPHALT PAYMENT ON THE STREETS RECENTLY COMPLETED IN THIS YEAR'S STREET IMPROVEMENT PROJECT WITH TARRANT COUNTY.

Requesting is to seal streets: Roberts Cut Off from River Oaks Blvd to Blackstone, Blackstone form Frontier to Churchill, Byrd from River Oaks Blvd to Shenna, and Woodlawn from Long to Hillside. That would be 23,038 square yards of sealant at a cost of \$95,978.91.

CM Claridge moved, seconded by CM Rodriguez to approve applying HA5 High Density Mineral Bond on the above streets. All voted "Aye".

There needs to be one single place that Public Information Requests are turned into. Will create an email for requests only instead of using the City Secretary's email address. All requests will be turned into the City Secretary's office and from there be distributed to department heads and then back to the City Secretary's office to send out.

CM Claridge moved, seconded by CM Rodriguez to approve Resolution #1073-2022 with the email change. All voted "Aye".

13. UPDATE ON PARK IMPROVEMENTS AT WOOLRIDGE PARK AS PRESENTED BY JILL WALKER.

Jill Walker was present. The school painted murals to put at the skate park. People are tagging the skate park with some of it being inappropriate. Normally taggers do not tag over other art, so hopefully this will prevent taggers. Some supplies have been purchased but need more. We can take the supplies out of the Park Maintenance budget. Christmas in Action offered to donate some supplies.
