7. CONSIDER APPROVAL OF RESOLUTION #968-2019 FOR SPECIAL EVENT PERMITTING TO HOLD CHARITY CAR TRUCK & BIKE SHOW ON JUNE 2, 2019 AS REQUESTED BY CASTLEBERRY ATHLETIC BOOSTER CLUB.

Dean Kuhn with the Castleberry Athletic Booster Club was present. This is the first car show which is for June 2, 2019 from 1-5 p.m. at W.O. Barnes Stadium at 215 Churchill. This car show is open to the public and concessions will be open.

Mayor Pro Tem Holland moved, seconded by CM Ashton to approve Resolution #968-2019. All voted "Aye".

8. CONSIDER APPROVAL OF BOND AMOUNT PURSUANT TO SECTION 4.05 OF THE CITY CHARTER AS AMENDED REQUIRING A SUFFICIENT SURETY COMPANY BOND CONDITIONED FOR THE FAITHFUL PERFORMANCE OF THE DUTIES OF CITY MANAGER.

The current bond is at \$50,000.00 which costs the city \$200 annually.

CM Ashton moved, seconded by CM Chisholm to leave the bond amount as is at \$50,000.00. All voted "Aye".

9. DISCUSSION AND/OR ACTION ON ROLE OF MAYOR APPOINTED COMMITTEES MOVING FORWARD DUE TO TRANSITION TO CITY MANAGER NOT OTHERWISE SUBJECT TO ARTICLE 1.04 "BOARDS AND COMMISSIONS" OF THE RIVER OAKS CODE OF ORDINANCES AS AMENDED.

These are Mayor appointed committees. The Planning Committee, Finance Committee, and Energy Work Group Committee are not covered under an Ordinance. Council agrees to leave the committees as is this year. The Finance Committee will remain in place but will not meet for pre-budget meetings like done in the past. The Finance Committee will be available if the City Manager has questions.

10. DISCUSSION AND/OR ACTION ON OTHER CHANGES WITH THE TRANSITION TO CITY MANAGER AS PRESENTED BY THE CITY ATTORNEY.

CA Elam updated the council on the transition. Currently the Code of Ordinances is being reviewed on the City Manager and City Secretary roles and will bring the Code of Ordinances back the end of June with the changes for approval.

11. DISCUSSION AND/OR ACTION ON AMENDING THE EVENT CENTER RENTAL POLICIES AND PROCEDURES REGARDING RENTALS.

There is nothing in writing stating if the rental goes way over the time limit and the renter does not clean the facility and the deposit does not cover the cost of the going over the time limit and the cleanup fees. The monitor, unless it is Shirley Wheat or Shirley Bloomfield, does not have access to the safe if the renter at the time of the rental wants to pay extra money to cover the overage and cleanup costs.

Council agreed to have City Manager Gregory, Shirley Wheat and CA Elam to come up with a policy.

At 7:51 p.m., Mayor Earwood opened the Public Hearing.

This is a very useful Ordinance and needs to be kept to have the ability to police the kids. The curfew hours are 11:00 p.m. on any Sunday, Monday, Tuesday, Wednesday or Thursday until 6:00 a.m. the following day; 12:01 a.m. until 6:00 a.m. on any Saturday or Sunday; and 8:30 a.m. until 3:00 p.m. on any Monday, Tuesday, Wednesday, Thursday, or Friday.

At 7:54 p.m., Mayor Earwood closed the Public Hearing.

13. ACTION FROM PUBLIC HEARING: CONSIDER APPROVAL OF ORDINANCE #1232-2019 PURSUANT TO SECTION 370.002 OF THE TEXAS LOCAL GOVERNMENT CODE READOPTING THE CITY'S JUVENILE CURFEW ORDINANCE EXPIRING ON APRIL 26, 2019.

CM Butler moved, seconded by Mayor Pro Tem Holland to approve Ordinance #1232-2019. All voted "Aye".

14. CONSIDER APPROVAL OF ORDINANCE #1233-2019 AMENDING THE FY 2019 BUDGET IN ORDER TO EXPEND FUNDS FROM THE WATER FUND FOR PRINCIPAL SERIES 2017 B.

The figures we had when we approved the budget were \$190,000 for the principal. We received the bill recently and the principal was \$225,000 which is correct according to the schedule.

CONSIDER APPROVAL OF ORDINANCE #1234-2019 AMENDING ARTICLE A.02 "SCHEDULE OF FEES AND CHARGES"; SPECIFICALLY IN SECTION A.02.001 "ESTABLISHED GENERALLY" SUBSECTION (b) BUILDING PERMIT FEES PURSUANT TO HOUSE BILL 852 EFFECTIVE MAY 21, 2019 THAT PROHIBITS CERTAIN VALUE-BASED BUILDING PERMIT FEES IN CONNECTION WITH THE CONSTRUCTION OR IMPROVEMENT OF RESIDENTIAL DWELLINGS; SECTION A.02.002 "REGISTRATION OF CONTRACTORS GENERALLY", SECTION A.02.003 "ELECTRICAL CONTRACTOR REGISTRATION" AND SECTION A.02.004 "FIRE PERMITS GENERALLY" OF THE CODE OF ORDINANCES OF THE CITY OF RIVER OAKS, TEXAS.

House Bill 852 was signed May 21, 2019 with effective date immediately to base building permit fees on square footage instead of estimated valuations. The revenue source should remain about the same.

CM Ashton moved, seconded by CM Chisholm to approve Ordinance #1234-2019. All voted "Aye".
