9. CONSIDER APPROVAL OF RESOLUTION #1104-2023 ADOPTING THE CITY OF RIVER OAKS 2023 PARKS AND RECREATION MASTER PLAN AS RECOMMENDED FOR APPROVAL BY THE RIVER OAKS PARK BOARD.

This item was done in Executive Session.

This master plan was based on the surveys that were filled out. UTA students and professors created the plan at no cost. They took the way the parks are now and created other things in each park. They also added the Community Center and the Masonic Lodge into the plan as a park. The parks included in this plan are McGee Park, Wooldridge Park, Community Center, and the Masonic Lodge property. The Park Board unanimously voted to approve this plan and to recommend it to the council for approval. This plan is based on all populations, not just kids. This plan will be used to get grants. The plans for each park don't have to happen immediately. The negative about this plan is they are naming two properties as parks that are currently not parks, and if we go to sell these properties, we must call for an election.

Joksan Holguin (Parks Board Member)-it is the understanding that this plan must be approved as is and no changes can be made.

Bob Jamison (Parks Board Member)-the grants that we get from this are city matching grants.

James Myrick (Parks Board Member)-this is a better plan than we had before. The negative is we must have an election to sell the parks listed in this plan.

# CM Turner moved, seconded by CM Rodriguez to approve Resolution #1104-2023. All voted "Aye".

10. HEATHER PHELPS OF ELATE PROPERTIES REQUESTING THAT THE CITY PROPOSE REVISED RESIDENTIAL GARBAGE COLLECTION POLICIES.

Heather Phelps was present. She and her husband own Boston Lane. Three homes have been sold and others are being looked at. Would like the garbage policy changed. Realtors have brought up about the trash on the curbs in River Oaks and they see trash strung out in the yards due to animals getting into the bags. Proposed is trash containers and the bags put into the containers. The proposed is two carts per household with a 32-max receptacle. During the summertime, the trash men fight the vultures. The trash men can either dump the can into the truck or pull the bags out.

Suggestion is to look at reduce bulk pick up twice a month, having one side of the city one week and the other side the next week. Suggestion is to not make the trash cans mandatory and making it optional.

This item will be brought back with an ordinance.

11. ADRIAN HERNANDEZ III REQUESTING REFUND OF DEPOSIT DUE TO CANCELLATION OF MAY 20, 2023 EVENT ON MAY 17, 2023.

12. LUZ BARBOZA REQUESTING APPROVAL TO HAVE A YEARD SALE/FUNDRAISER FOR THE CASTLBERRY CLASS OF 2024 AT THE RIVER OAKS EVENT CENTER ON JULY  $15^{TH}$  AND JULY  $29^{TH}$ , 2023.

No one was present. The council agreed to let City Manager Gregory handle this request.

13. CONSIDER APPROVAL OF INTERLOCAL FUNDING AGREEMENT WITH TARRANT COUNTY UNDER THE 2021 TRANSPORTATION BOND FOR STREET IMPROVEMENTS ON BARBARA ROAD FROM ROBERTS CUT OFF ROAD EAST TO CHURCHILL ROAD.

Long Street is next then Barbara Road is after that. Commissioners Court passed this on June  $6^{th}$ , 2023.

CM Holland moved, seconded by CM Turner to approve the Interlocal Agreement with Tarrant County. All voted "Aye".

14. CONSIDER APPROVAL TO EXTEND THE SUBSTANDARD BUILDING ORDER ON THE PROPERTY AT 4844 HARTFORD THAT WAS PREVIOUSLY EXTENDED 60-DAYS ON MARCH 14, 2023 TO MAY 13, 2023.

Arlynn Purvis was present. He is on his third contractor now. Progress is being made and feels he will be finished in six weeks. BI Sanders mentioned that inspections are not being done weekly. The original order was for weekly inspections. The electrical and driveway are the only inspections that have been done. The council ordered BI Sanders and CM Gregory to meet Mr. Purvis at the house and to give the council an update at the next meeting.

15. DISCUSSION AND/OR ACTION ON SELLING OLD STREET SIGNS THAT HAVE BEEN REPLACED BY THE NEW STREET SIGNS.

Have received several calls about purchasing the street signs. Club Oak has only one sign to sell, and several people want it. Council agreed to sell the signs for \$30.00 each and to publicize a set date and time to sell them.

Board appointments are done by the Mayor. We have more applicants this year than we ever had. Mayor agreed that the boards should have input. This item will be brought back with an Ordinance.

CONSIDER APPROVAL OF ORDINANCE #1379-2023 AMENDING CHAPTER 12 "TRAFFIC & VEHICLES" IN ARTICLE 12.05 "STOPPING, STANDING & PARKING" UNDER SECTION 12.05.013 "SPECIAL TIME LIMIT NO PARKING ZONES" ADDING SUBSECTION (f) "700 SPRINGER AVENUE" DESIGNATING A SPECIAL TIEM LIMIT NO PARKING ZONE ONLY ON SCHOOL DAYS BETWEEN THE HOURS OF 7:00 A.M. AND 4:00 P.M.

The resident at 700 Springer (corner of Springer & Barbara) has issues with people parking in their yard because there are no curbs during school days.
