Mickey Thomas with MJ Thomas Engineering was present. The city has had the same drainage ordinance for many years. Many organizations have been forced to adopt the iSWIM manual and our neighboring cities have adopted it or are in the process of adopting it. This is an elaborate ordinance, but it covers everything. This manual will bring additional benefits to the city and to residents. This program will not affect TXDOT's program. TXDOT will go by their program.

This is a draft agreement for the encroachment and the school will maintain the detention pond. Requesting to authorize CM Gregory to sign the agreement when it is approved by all parties. Mickey Thomas with MJ Thomas Engineering was present. There is an existing water and storm water main that goes under the ballfield, under the turf. The school district will be responsible for replacing the turf if the city has to go in and maintain the mains.

CM Holland moved, seconded by CM Rodriguez to approve authorizing CM Gregory to sign the agreement when it is approved by all parties. CM Holland, CM Rodriguez, Mayor Pro Tem Chisholm, and CM Claridge voted "Aye". CM Turner abstained from voting.

PWD Smith presented a compressed work schedule, salary surveys summary, one-time inflation retainage agreement, sign-on bonus, and on-call pay.

Compressed work schedule-Option 1 is City Hall and Public Works open from 7:30 am-5:30 pm and closed on Friday. Option 2 is City Hall and Public Works open from 7:30 am-5:30 pm with an hour lunch which City Hall will be closed during that hour, and four hours on Friday. Option 3 is keeping the existing work schedule.

Salary survey-Public Works and City Hall employees are \$1-\$4 behind and hour in pay than other cities.

One-time inflation retainage agreement-existing employees get a one-time inflation offset payment of \$1,000 for agreement to stay one year. If an employee leaves during the one year, the employee pays back the payment in prorated amount for the months stayed during the year.

Sign-on bonus-one city is offering Public Works a \$1,000 sign on bonus for the first six months and another \$1,000 at the end of one year.

On-call pay-we require two employees to be available for on-call for after hours for emergencies. It is a rotating schedule. As of right now, we only compensate if the employee gets called out. Recommended is an employee who is on call receives \$50.

After much discussion, council is requiring more information be brought back.
