## **PUBLIC HEARING/ACTION FROM PUBLIC HEARING:**

8. PUBLIC HEARING: APPLICANT, ROSETTA BOGGS %TRINITY BAPTIST CHURCH IS REQUESTING A SIGN VARIANCE ON THE PROPERTY AT 5641 TAYLOR ROAD FROM ARTICLE 3.12 "SIGNS", SECTION 3.12.134 IN ORDER TO BE ALLOWED TO ERECT AN OFF-SITE SIGN THAT IS OTHERWISE NOT PERMITTED ON THE REAR OF THEIR PROPERTY THAT IS VISIBLE TO THE MOTORISTS WHEN ENTERING THE CITY OF RIVER OAKS THAT ADVERTISES SERVICE TIMES FOR TRINITY BAPTIST CHURCH.

Rosetta Boggs withdrew the request. Robert Brown, representing Trinity Baptist Church, was present and is requesting a refund on the application. The costs the city has in this is staff time and postage which amounts to about \$69.60. The church has done a lot for the community.

9. ACTION FROM PUBLIC HEARING: CONSIDER APPROVAL OF THE VARIANCE REQUEST OF ROSETTA BOGGS %TRINITY BAPTIST CHURCH AT 5641 TAYLOR ROAD FROM ARTICLE 3.12 "SIGNS", SECTION 3.12.134 IN ORDER TO BE ALLOWED TO ERECT AN OFF-SITE SIGN THAT IS OTHERWISE NOT PERMITTED ON THE REAR OF THEIR PROPERTY THAT IS VISIBLE TO THE MOTORISTS WHEN ENTERING THE CITY OF RIVER OAKS THAT ADVERTISES TIMES FOR TRINITY BAPTIST CHURCH.

Mayor Pro Tem Claridge moved, seconded by CM Turner to approve the full refund request of the sign variance application. Mayor Pro Tem Claridge, CM Turner, and CM Rodriguez voted "Aye". CM Forester voted "Nay". Motion passed.

## PERSONAL APPEARANCES AND/OR ITEMS REQUIRING COUNCIL APPROVAL/ACTION:

10. CONSIDER APPROVAL TO ENTER INTO A CONTRACT WITH WASTE CONNECTIONS FOR COMMERCIAL SOLID WASTE AND LANDFILL SERVICES.

Norm Bulaich and Abel Moreno present. This contract does not have to be bid out. Rates have increased 4% which is still under what the city is recouping. It was suggested to look at getting quotes from other companies. The problems are finding a landfill is difficult and no other companies will let the city do their own residential pick up. Yes, the city can go onto the open market but having multiple trucks on the streets are hard on the streets. The new agreement will start October 1, 2023.

# CM Forester moved, seconded by CM Rodriguez to enter into a contract with Waste Connections subject to City Attorney approval. All voted "Aye".

11. CONSIDER APPROVAL OF REQUEST FROM ANDRES GONZALES AT BOULEVARD CUSTOMS LOCATED AT 5441 RIVER OAKS BLVD TO INCLUDE MINOR AUTOMOBILE REPAIRS WITH HIS CURRENT USE FOR MOTORCYCLE REPAIRS.

This item was discussed in Executive Session.

12. DISCUSSION AND/OR ACTION ON THE HWY 199 SUP STAKEHOLDER COORDINATION MEETING DATED JULY 19, 2023.

Originally there was a 33' easement which would cause the city to loose businesses. So, they came back and shaved off 7' making it a 26' easement which would impact a few businesses on their parking. The project consists of reconstructing and widening a 4-lane divided roadway with raised medians and outside shoulders to a 6-lane divided urban roadway with raised medians, sidewalks or shared use paths, curb & gutter, and intersection improvements.

We had a company come in with 52 people to apply for solicitation permits. Currently the application fee is \$35.00 and no permit fee. There is a \$10.00 fee for each applicant. There is a

lot to do when it comes to issuing solicitors permits. We are proposing changing the fees to an annual application fee of \$50.00 per company, and \$50.00 per individual and both are non-refundable. The annual permit fee would be \$100.00 per company and \$100.00 for each applicant. If the company employes minors that are wanting to solicit, the cost would be \$125.00 for each minor applicant.

CM Forester moved, seconded by CM Rodriguez to approve Ordinance #1384-2023. All voted "Aye".

Andres Gonzales was present. He opened a motorcycle repair shop and wants to include minor automobile repairs to make ends meet. Otherwise, he may have to shut down. He is willing to put up a screened fence if needed to. CA Anderlee-would require a zoning amendment. The ordinance also prohibits a car wash and detailing in that location. Council cannot approve this request.

We did get approved for the backhoe grants. We applied for two, but we can get one or both. The oldest one is 29 years old, and we are unable to get any parts for it. We would receive \$96,000.00 reimbursement for this one. Our cost for one is \$34,000.00. The second backhoe we would get \$75,000.00. The current backhoes will have to be destroyed and we can sell for scrap. The \$34,000.00 for the oldest one would come out of the Water-Sewer fund. Council agreed to move forward with the one and to bring back for official council approval.
