5. DISCUSS 2023 TAX RATE, TAKE RECORD VOTED.

Items #5 & #6 were discussed together. The proposed budget has been filed in the City Secretary's office. It is recommended to go with the no-new-revenue tax rate or the voter-approval rate and not the de minimis rate. The recommended voter rate of \$0.677621/\$100 will bring in \$3,441,762.00 in property tax revenue. That is the maximum rate we can go but we can go down from that without an election. If we approve the voter-approval rate, the general fund will have a deficit of \$44,240.00.

Council Members went over some items in the budget. The Fire Department step plan is based on 3%. The Police Department has presented a new step plan. The General Fund has about \$270,000.00 more in revenues due to EDC helping. Expenses are up about 5% mainly due to inflation and personnel costs. We are starting to see good things with the Enterprise Lease Program. Getting vehicles is and has been an issue and the vehicles have increased in price. There are four Public Works vehicles that have not been sold and there are a few in the Police Department. We have proposed \$215,000.00 of revenue in vehicle sales. Council would like to have Enterprise meet with them and let us know how we are doing compared to what was expected.

CM Forester moved, seconded by CM Holland to publish the voter approval tax rate of \$0.677621/\$100 as presented by the City Manager. All voted "Aye".
