Bill Atkins, a volunteer with Texas Ramp Projects was present. These ramps are built at no cost to the homeowner. They build many ramps in other cities. A ramp was being built in River Oaks and Code Enforcement informed them a permit is required. Council agreed that the project needs to be called into the permit department.

CM Claridge moved, seconded by CM Rodriguez to waive permit fees and to waive the permit requirements for Texas Ramp Project. All voted "Aye".

9. CONSIDER DIRECTOR VACANCY APPOINTMENTS PURSUANT TO SECTION 2.4 OF THE BYLAWS OF FRIENDS OF THE ANIMAL SHELTER, A 501(C)(3) NON-PROFIT CORPORATION.

CM Claridge moved, seconded by CM Rodriguez to appoint Chuck Stewart as President, Brody Beasley as Vice-President, Marvin Gregory as Secretary, Paula Luck as Treasurer, and Yolie Rodriguez as the Council Liaison. All voted "Aye".

Mayor Pro Tem Chisholm moved, seconded by CM Claridge to re-appoint Shirley Wheat as President, Shirley Bloomfield as Vice-President, Paula Luck as Secretary/Treasurer, and John Claridge as Council Liaison. All voted "Aye".
