8. CONSIDER APPROVAL OF EMPLOYEE HEALTH, LIFE & MEDICAL INSURANCE RATES FOR PLAN YEAR OCTOBER 1, 2023 THROUGH SEPTEMBER 30, 2024 AS PRESENTED BY DAWN BRINSON, BRINSON BENEFITS.

Dawn Brinson was present. The Blue Cross Blue Shield renewal originally came in at a 18.09% increase. After negotiations, the increase is 2.42% if we choose Alternate #1. The deductible increased to \$6,000.00 for individual, the primary visits copay decreased, the specialist visit decreased, the co-insurance is 70% and the out-of-pocket max is \$8,150.00. The HRA reimbursement will be anything towards the deductible over \$1,000.00 and up to \$5,000.00. The Dental, Vision, and Life Insurance remains the same. The city pays for a basic \$50,000.00 life insurance policy for each employee. The city also pays for Telemedicine which covers everyone in the employee's household.

CM Forester moved, seconded by CM Holland to approve the employee insurance rates as presented. All voted "Aye".

9. CONSIDER APPROVAL TO EXTEND THE SUBSTANDARD BUILDING ORDER ON THE PROPERTY AT 4844 HARTFORD THAT WAS PREVIOUSLY EXTENDED TO AUGUST 8, 2023.

Arlyn Purvis was present. The plumbing was mis-budgeted. Did not realize how long the plumbing would take. The plumbing fixtures are not installed, and the plumbing has not been finaled. Huge progress has been made. Would like an extension until the middle of September.

CM Turner moved, seconded by CM Rodriguez to extend the Substandard Building Order for 4844 Hartford to September 21, 2023. All voted "Aye".

10. CONSIDER APPROVAL OF TEXAS MOTOR VEHICLE RECORDS DATA CONTRACT AUTHORIZING THE CITY MANAGER TO EXECUTE THE CONTRACT.

This is used by Code Enforcement for vehicle inquiries. This is a new free contract. Currently we pay monthly for this service.

CM Forester moved, seconded by CM Rodriguez to approve the contract with Texas Motor Vehicles. All voted "Aye".

CONSIDER APPROVAL OF RESOLUTION #1108-2023 APPROVING A NEGOTIATED SETTLEMENT BETWEEN THE ATMOS CITIES STEERING COMMITTEE ("ACSC") AND ATMOS ENERGY CORP., MID-TEX DIVISION REGARDING THE COMPANY'S 2023 RATE REVIEW MECHANISM FILING; DECLARING EXISTING RATES TO BE UNREASONABLE; ADOPTING TARIFFS THAT REFLECT RATE ADJUSTMENTS CONSISTENT WITH THE NEGOTIATED SETTLEMENT; FINDING THE RATES TO BE SET BY THE ATTACHED SETTLEMENT TARIFFS TO BE JUST AND REASONABLE AND IN THE PUBLIC INTEREST.

Darwin Winfield was present. The coalition started in 2018 and that is when River Oaks joined it. A settlement has been reached with Atmos. The new settlement is a \$6.47 per household per month increase and a \$24.72 per business per month increase.

CM Holland moved, seconded by CM Rodriguez to approve Resolution #1108-2023. All voted "Aye".

WORK SESSIONS & ACTION FROM WORK SESSION:

12. WORK SESSION: FY 2023 CITY OPERATIONAL BUDGETS (OCTOBER 1, 2023-SEPTEMBER 30, 2024).

The General Fund has a surplus of \$26,360.00; Water Sewer Fund has a surplus of \$994.00; Improvement Bond has a surplus of \$2,057.00; Crime Control has a deficit of \$13,637.00; Economic Development has a surplus of \$45,182.00; Storm Water balances, TIRZ has a surplus of \$110,554.00; Animal Shelter has a surplus of \$3,350.00; and Community Center Foundation balances. The budget has been posted on the website based on the voter approval rate at 0.677621 per \$100.00.

Council would like to revisit the Event Center rental agreement and look at some training for the directors. Need to look at an action plan on what their goals are and what their plans are to increase rentals. Would like a record of how many people are attending the events (bingo, karaoke, jam, etc.).

Fort Worth sewer rates have increased. We will increase the resident's rates by 13.7% and commercial accounts by 11.8%. Council asked several questions on the Water Sewer Fund.

The TIRZ revenue is budged at 75% county participation, 50% college participation, and 75% city participation. We can get with Petty and Associates to do a presentation on what we can spend the TIRZ money on.

The Storm Water revenue is based on \$6.00 per month per account on residential and it is based on square footage on commercial.

The purpose of the Animal Shelter 501c3 is to build a new shelter.

PWD Bell-Barbara Road is in four phases. The paving crew was supposed to be now in Phase 1 but was set back to August 21, 2023. Both sections will be paved at once.

CM Holland-last Wednesday was school events. In attendance was himself, Mayor Houk, Pete Geren, and city employees were working a couple of tables. The superintendent is doing a great job.
